Spring & Summer City Ordinance Reminders

Code Enforcement

Grass and Weeds

Properties in the City are required to cut or remove all weeds and "noxious growth" (including grass) of excessive length. This does not include trees, shrubs, cultivated flowers, or gardens. Homes found in violation are subject to fines and will be maintained by the City with expenses charged to the homeowner.

Garbage and Recycling Carts

Outdoor storage of garbage by a property owner or occupant in the terrace area or yard of a residential property is prohibited unless in a covered and approved container for a period not to exceed 24 hours. Bulky materials (such as furniture or brush) may also be placed without a container for up to 24 hours while waiting for pickup. Containers or materials left for more than 24 hours (including garbage cans, recycling containers, and brush) may be issued a citation.



Outdoor Storage of Household Furniture and Appliances

Homeowners may not store or use furniture or appliances designed for indoor use on an open porch or in their yard for a period of more than 24 hours. This includes but is not limited to cushions, pillows, mattresses, couches, chairs, washers, dryers, refrigerators or freezers.

Compost Site Hours

The Compost Site it now open for the season. City of Sturgis and Sturgis Township residents can access the site free of charge, others must purchase a pass for \$35.00. Non-City residents will need to register and obtain a compost pass card at the Clerk's Office in City Hall to access the compost site.

2013 Street Millage

The City Commission approved the placement of a dedicated street millage on the May 7th ballot. These funds would be dedicated to improve the streets and sidewalks in the City of Sturgis.

The ballot language is as follows:

"Should the City of Sturgis levy a new three (3) mills property tax for a period of ten (10) years commencing in calendar year 2013 to be used exclusively for street and sidewalk reconstruction, repair, and improvement projects as approved by the Sturgis City Commission? The estimated increase in revenue to be collected by the City in the first year if the millage is approved is \$770,652.00."

A **YES** vote means that the City of Sturgis will have dedicated funding through a tax collection to improve the condition of a number of streets in the City over the next 10 years . A **NO** vote means that the City of Sturgis will continue to complete street repairs as funding is available using operating tax dollars. Based on current funding, City officials believe the streets will continue to get worse over time. For more information, please visit www.sturgismi.gov.
