ITEM 2. SHELBY MOORE
1102 SOUTH MAIN STREET
STORM DRAINAGE ISSUES

Ms. Shelby Moore of 1102 South Main Street has asked for time on the Board's agenda to discuss storm drainage issues affecting her property at the above address.

For a number of years, Ms. Moore has been in contact with the Town regarding these issues which stem from storm water collected on South Main Street (U. S. 23-74 Business) and being deposited on her property. When she has contacted the town, our Public Works personnel have advised that the water comes from Main Street which is under control of the N. C. Department of Transportation. We understand that Ms. Moore has made contact with the N. C. DOT on more than one occasion, and they advise that they have no plans to make changes in the flow of the storm water. In the past the N. C. DOT has taken the position that once it leaves the street rights-of-way, they have no further responsibility for that storm water.

Ms. Moore has asked for time to appear before the Town Board to discuss the situation.



ITEM 3. APPOINTMENT/REAPPOINTMENT ALCOHOLIC BEVERAGE CONTROL BOARD

The term of Mr. Earl Clark on the Alcoholic Beverage Control Board will be expiring on August 15, 2010. Mr. Clark has served on this Board for several years and is currently holding the position of Chairman of the Board. He has completed an application and expressed an interest in continuing to serve on this Board. If the Town Board chooses to reappoint Mr. Clark, it will be for a three year term that would expire August 15, 2013.

ITEM 4. RECOMMENDATION TO CANCEL TOWN BOARD MEETING OF AUGUST 10, 2010

When my wife and I began planning our annual vacation last winter, I knew it would be in conflict with the Board meeting of August 10; however, I had full confidence that Assistant Town Manager Alison Melnikova could handle the managerial duties at that meeting.

Later, I spoke with Alison and encouraged her to apply for the Public Executive Leadership Academy training sessions in Chapel Hill for the educational benefits.
