## REGULAR MINUTES HISTORIC PRESERVATION COMMISSION TOWN OF WAYNESVILLE

1. Regular Meeting Minutes of April 2, 2014

# Vice-Chairman Ann Melton made a motion to approve the minutes of the April 2 regular meeting as presented; Henry Foy seconded and all were in favor.

2. Love Lane Sign—Ann Melton

Vice-chairman Melton presented commissioners with a draft sign drawing she would like to have crafted and posted at the entrance to the Love Lane neighborhood:

Love Lane Waynesville's Oldest Residential Street Circa 1870

There were three dimensions offered: 30x20; 36x24; and 40x27. Ms. Melton hopes to have the sign installed atop a rock pillar on the back of Stonegate Office Park, commercial building property at the corner of Dellwood and Love Lane so it will be visible upon entering Love Lane (placement details have not been worked). After discussion, members chose the largest dimensions, 40x27 for visibility. Town Planning Director Paul Benson agreed the sign dimensions are acceptable according to town standards. The Town of Waynesville's Board of Aldermen has approved funding of the sign.

Henry Foy made a motion to accept the Love Lane sign as presented specifically with wording: *Love Lane Waynesville's Oldest Residential Street circa 1870* and dimensions: 40x27. Peter Sterling seconded and all were in favor.

3. Strand Theater Sign—Paul Benson

Lorraine Conard requests the Historic Preservation Commission approve, for 180 days, the temporary informational banner sign on her Main Street building, The Strand. Currently, Ms. Conard is in violation of the sign ordinance and without HPC approval will be issued a citation. Ms. Conard plans to request a permit for a more permanent marquee sign, illuminated with changeable letters topped by large STRAND lettering, with specifications forthcoming.

## Vice-Chairman Ann Melton made a motion to grant owner Lorraine Conard 180 days with the temporary banner informational sign. Henry Foy seconded and all were in favor.

4. Other Business

## Membership

• Commissioners Nikki Owens and Shawn Leatherwood—

Chairman Sprecher announced Shawn Leatherwood sent in his letter of resignation. Nikki Owens has failed to meet attendance requirements and will not return phone calls. Mr. Benson and others were confused because Ms. Owens expressed to him that she wanted to continue to serve Mr. Benson said the commission can make a motion the position is vacant and ask the Board of Aldermen to make an appointment. Sandra Owen offered to contact Ms. Owens in person. Members agreed to table the issue one month.

• Nominations for Historic Preservation Commission—

Peter Sterling nominated three people for service to the Historic Preservation Commission: Ron Sullivan, Lee Starnes and Ron Huelster. Paul Benson reported there is currently an application on file from Mr. Glenn Duerr, owner of Windover Inn Bed & Breakfast which will go before the Board of Aldermen at their regular meeting on June 17<sup>th</sup>. Marguerite Russ Metcalf was also mentioned as a potential candidate.

#### Love Lane Designation

Discussion about the feasibility of Love Lane as a local historic district continued. Love Lane does not meet approval by the State as a National Historic District due to several properties with vinyl and aluminum siding. Therefore, local historic district status is being explored. Since the State will not fund research for local historic district designation and the cost for a professional report can be \$10,000, members discussed their views: "grandfathering in" properties with aluminum/vinyl siding and pursuing local district status; considering properties

on a case-by-case basis as local landmarks; concern over the legalities that might ensue if siding is acceptable for some homes; and how siding is simply unacceptable for historic properties.

Mr. Benson expressed his directional stance--Since Main Street is already a National Historic District with thorough research mostly complete, it may be more feasible to pursue local historic district designation for Main Street.

### **Greenhill Cemetery**—Ann Melton

Vice-Chairman Ann Melton read an email from the State Historic Preservation Office's Preservation Specialist Annie McDonald in response to Ms. Melton's recent study list application regarding Greenhill Cemetery's potential designation:

I just wanted to let you know that I received the Study List application for the Green Hill Cemetery on Friday, May 2<sup>nd</sup>. I'll be presenting it to the other National Register staff at our Staff Review meeting on Thursday, June 5<sup>th</sup>, followed by a formal presentation to the National Register Advisory Committee on Thursday, May 12<sup>th</sup>.
