Chairman George Kenney welcomed everyone and called the meeting to order at 4:04pm.

1. Minutes from the September 14, 2023 Regular Meeting

CJ made a motion, seconded by Ashten, to accept the September 14, 2023 minutes as presented. The motion passed unanimously.

2. 6th Annual Dog Show Recap

Jesse recommended that the Public Art Commission should start advertising the event much earlier next year, and more members should help Skip solicit donations and sponsorship. Chairman George suggested potentially removing the "Dog Lookalike" contest. Jesse reported that WPAC grossed ~\$1000 from the event. Chairman George added that next year, the dog show should be scheduled so that it doesn't conflict with Sarge's event so they can participate as well.

3. Call for Artists and RFQ Preliminary Review

Jesse presented the Call for Artists-Request for Qualifications. He asked each Commission member to review the RFQ and offer edits and recommendations before the next meeting. He said the next meeting, WPAC will finalize the RFQ.

4. Upcoming Event Participation and Logistics

Jesse reviewed the event postings for the Church Street Festival on the 14^{th} and Apple Festival on the 21^{st} .

5. Church Street and Apple Festivals

Jesse said that October 14th is the Church Street Festival from 10am to 5pm. George offered to man a shirt selling booth for the 10am-1:30pm shift, and CJ would work from 1:30 to 5pm, Jesse said the Apple Festival is October 21st. Ginny volunteered to man the shirt selling booth from 10am-1:30pm and Ashten volunteered for the 1:30pm-5pm shift. Jesse said he will secure a way to take credit cards for the tabling events.

6. Other Business

Chairman George suggested moving the Folkmoot art piece. He said that is almost completely covered by a tree by the police station. Doug said it should go back near Folkmoot. Steve suggested that it goes near SOAR Academy for Learning. Jesse said he will look at the map and figure out where WPAC can get an easement to relocate the art piece.

There being no further business to discuss, Vicki made a motion, seconded by Doug, to adjourn. The motion carried unanimously. The meeting was adjourned at 4:42 p.m.
