Jesse said that he spoke with the Beth Gilmore about selling t-shirts on the street at Art After Dark, and she said that some merchants have issues with that. He added that at the next Art After Dark will also be the Mountain Street Dance (August 4<sup>th</sup>). He recommended that the Commission sells shirts then. Jesse, Doug, and Ashten volunteered to be there to sell shirts.

George said the Dog Show is scheduled for September 24<sup>th</sup> at 5:30pm. George asked Jesse to recreate the poster from last year. It was suggested to do a "kissing booth" with a suggested donation for attendees to pay to have their photo taken with their pet and emailed to them. George said he would work on securing a 20'x30' tent. Jesse said he will confirm with the Police Department for them to a K-9 demonstration. There was discussion about inviting "Flying dogs" group. Jesse said we can advertise on Facebook, local shelters, the newspaper, and the Town newsletter. Skip recommended asking a local vet clinic to sponsor.
