## Minutes Waynesville Parks and Recreation Advisory Commission February 12, 2002

Chairman Kenny Mull called the meeting to order at 6:40 p.m.

In attendance were; Kenny Mull, Dot Evans, Lee Starnes, Wallace Messer, and Kitty Eaker. Also present were; Donald Hummel and Michael Smith.

## Old Business:

Members read a copy of letters sent to the governing board by Bill Jones. Bill complains that he has been dealt with unfairly about the incident with he and Brad Bell, and the Tuscola Women Tennis Team and coaches. There is the possibility that the coach got Bill and Brad mixed up and that Brad did the cursing instead of Bill. We will contact the coach to reconfirm the accusation. We will also contact other tennis facilities to see if Brad or Bill have had problems there. In the mean time a letter will be sent to Bill stating that we are doing some follow up work on the incident and will discuss it at the March meeting. Further, Bill's statement that he has been "good" for the past 1 to 2 years is in error. I sent a memo to Malcom Beasley in July of 2001, about another tennis player who complained that Bill was cursing out loud while some young girls were playing tennis. He was asked to stop but instead got louder. Bill even yells at people in the park if they make noise.

## **New Business:**

The Playground Build is scheduled for April 17-21. Members were invited to participate.

The February newsletter was distributed.

Bitty ball finished the season last week.

An organization meeting for men softball was held February 11and 17 teams are scheduled to play.

We hosted the Haywood County basketball league on Saturday. Three hundred dollars was taken in via spectator fees.

Yoga and water aerobics continues to be successful.

A request to use the horse ring area was received from Mountain Regional Veterinary Service. They want to do blood tests on horses (Coggins test) and charge \$15.00 per horse. Wallace made the motion to deny the motion based on the following. There is a \$15.00 fee per horse and the same service is offered at other animal hospitals for as low as \$17.50. The use of our facility would be free, resulting in them undercutting competitors prices. Recreation property cannot be used for personal gain.
