

ORDINANCE NO. O-16-34

AN ORDINANCE AMENDING SECTIONS 1729.02(B)(1)(a) OF THE CODIFIED ORDINANCE OF THE CITY OF WILMINGTON MODIFYING THE PERIOD OF TIME EXTENDED FOR COMPLIANCE AFTER OFFICIAL NOTICE OF A VIOLATION OF 1729.02.

WHEREAS, it is deemed to be in the best interests of the citizens of the City of Wilmington that the City effectively enforce laws prohibiting individuals from littering upon public places

WHEREAS, The Council of the City of Wilmington, having the authority to amend alter or repeal all City Ordinances or Codes, desires to amend Section 1729.02(B)(1)(a) regarding compliance procedures; and

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILMINGTON, STATE OF OHIO:


Section 1. That Section 1729.02(B)(1)(a) of the codified ordinances as enacted by ordinance No. 4605 passed on the 20th day of April, 2006 hereby amended to read as follows:

*Section 1729.02(B)(1)(a) Litter is on such lands and that it must be removed within **FIVE (5) DAYS** after the service of such notice;*

Section 2. That existing Section 1729.02(B)(1)(a) of the codified ordinances enacted by ordinance No. 4605 on the 20th day of April, 2006 is hereby repealed.

Section 3. This ordinance shall take effect and be in full force from and after the earliest period allowed by law.


