## ORDINANCE NO. <u>O-17-09</u>

AN ORDINANCE APPROVING THE EDITING AND INCLUSION OF CERTAIN ORDINANCES AS PARTS OF THE VARIOUS COMPONENT CODES OF THE CODIFIED ORDINANCES OF WILMINGTON, OHIO

WHEREAS, various ordinances of a general and permanent nature have been passed which should be included in the Codified Ordinances of Wilmington, Ohio;

NOW, THEREFORE, be it ORDAINED by the City Council of Wilmington, Ohio, that:

Section 1. That this ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health and safety of the Municipality and its inhabitants for the reason that there exists an imperative necessity for the adoption of the new Traffic, General Offenses and Fire Prevention Code amendments, so as to avoid conflict with general State law, and shall be effective on the effective date of this ordinance.
