AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH DAYTON POWER AND LIGHT ENERGY RESOURCES, INC./MIAMI VALLEY LIGHTING, INC. REGARDING RECEIVING AN ENERGY COST DISCOUNT THROUGH DECEMBER 31, 2012 FOR QUALIFYING CITY ACCOUNTS AND DECLARING AN EMERGENCY

WHEREAS, the lighting of roadways and neighborhoods enhances public safety and security, and

WHEREAS, the State of Ohio and the Public Utilities Commission of Ohio (PUCO) have made certain options available pertaining to the supply of electric generation and transmission supply services, and

Section 1. That the Mayor is authorized to execute and submit (a) proposal(s) on behalf of the City of Wilmington with the Ohio Department of Transportation to aid in the financing of capital and operating assistance projects pursuant to 49 U.S.C. Section 5311 and the Ohio Public Transit Grant Program.

Section 2. That the Mayor is authorized to execute and file with such proposal and assurance or any other document required by the U.S. Department of Transportation effectuating the purposes of Title VI of the Civil Rights Act of 1964.

REPEALING ORDINANCE 2467, AND ADOPTING A SCHEDULE TO PROVIDE FOR THE OBSERVANCE OF LEGAL HOLIDAYS FOR CITY EMPLOYEES, AND DECLARING AN EMERGENCY

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILMINGTON, STATE OF OHIO

Section 1. That Ordinance No. 2467 of the City of Wilmington regarding the holiday schedule be and hereby is repealed in its entirety.

Section 2. That for the year 2010 and thereafter, the following legal holidays shall be observed by full-time non-bargaining unit City employees: New Year's Day, Martin Luther King Day, Presidents Day, Memorial Day, Independence Day, Labor Day, Veterans Day, Thanksgiving Day, the day after Thanksgiving Day, and Christmas Day.

Section 3. That when the holiday falls on a Saturday, it shall be celebrated on the preceding Friday. When the holiday falls on a Sunday, it shall be celebrated on the following Monday.

Section 4. That for the year 2012 and thereafter, the following legal holidays shall be observed by full-time non-bargaining unit City employees: New Year's Day, Martin Luther King Day, Memorial Day, Independence Day, Labor Day, Veterans Day, Thanksgiving Day, the day after Thanksgiving Day, Christmas Eve, and Christmas Day.

Section 5: That for the year 2012 and thereafter, in years in which Christmas Eve falls on Friday and Christmas Day falls on Saturday, these holidays will be observed on Thursday and Friday, respectively. In years in which Christmas Eve falls on Sunday and Christmas Day falls on Monday, these holidays will be observed on Monday and Tuesday, respectively.

Section 6. That the holiday schedule applies to all full-time non-bargaining unit City employees with the exception of service departments and/or personnel who work for service departments who are deemed necessary to work on an observed holiday in order to continue to provide essential services to the citizens. Scheduling of holidays for these employees will be left to the discretion of the department supervisors.

Section 7. That provisions of any ordinances and resolution which are inconsistent herewith are hereby repealed.

Section 8. That this ordinance is hereby declared to be an emergency measure necessary to the immediate preservation of the public health, safety and welfare to provide for immediate implementation of an employment benefit and shall be in full force and effect immediately upon its passage.
