Wilmington Parks and Recreation Board Meeting Minutes April 14, 2014 Regular Meeting 6:00 P.M. Shelter A Denver Williams Memorial Park

In attendance: Lori Williams, Maria Butcher, Leilani Popp, Mac McKibben, Peter Thorburn, Jen Stewart, Sean Gibson, Zachary Bradshaw, Val Robinson, Gary Huffenberger plus two more unnamed in attendance.

Butcher; Roll Call, Review and Acceptance of Minutes from March 3, 2014. Moved by Popp to be accepted as is, seconded by McKibben, motion carried.

Butcher opened with Old Business with an update of the Skatepark Project. Williams began with an update from the Parks perspective, the nets are down on the front tennis court, and we've picked up a couple pieces of equipment from OSU.

We have a picnic table for the course, a half pipe, a wedge. It is at Wastewater on the trailer, we are just waiting for them to tell us when they are ready to install it, as soon as it dries out to keep from sinking in the soil.

Williams has been in touch with "Lew" of Fickleboards who lives in Cincinnati, and he has looked at the half pipe plans we had, Lou says the drawings were "backyard" equipment and proposed a much larger piece that would be around \$20,000.00, but could get it for \$15,000.00 put together by three people who knew what they were doing. To do it he would have to work as a sub for someone local who the Parks would have a contract with and he would be a subcontractor.

A discussion followed, Stewart talked about the grant monies, the Tony Hawk grant restrictions, and the worry that a temporary park would present some problems in raising money for the permanent concrete park. Also she and Thorburn told about the equipment behind the old News Journal building has been moved and or locked up about two weeks ago and how the skaters are in need of a place to skate. Thorburn talked about bringing the equipment they have up to code for placement in the Parks and adding it to what we have. They have two quarter pipes and a box.

A discussion followed concerning the logistics of repairing the older stakepark equipment and getting it placed in the park with the OSU equipment. Also discussion occurred about public awareness and fund raising for the permanent park.

Williams advised on May 20, 21, & 22, 2014 Alkermes will be working in the park for their Company Community Service Project and we can have them help with this project.

Butcher moved us into an update of the Proposed Dog Park Project, Williams advised that the group is moving forward and looking forward to getting it done. We are very close to starting the bulldozing.

Butcher then moved into the SECPT Project; Robinson showed a sign example that she has worked up, it was well received and will be used, Williams will send it to Graphics to Go to digitalize it for reproduction. The orders have been placed for the needed equipment. We had some WC Early Ed class students working on landscaping and got a lot of it done. The WCS Tile Art project has been re-scheduled for next fall. Hoar wants to add something to the tire pyramid but we are afraid it won't be to code, we will talk with him by webcam next week.

Williams gave an update on scheduled upcoming events, the Kiwanis Bike Rodeo and Heathers Hope will be on May 17th.

Williams gave us the grant updates, Nature works project agreement has been signed the work schedule will be announced, CDBG the purchase order through the commissioners has been placed for GameTime and Kompan equipment. The asphalt overlay for the basketball court and elephant play equipment must be competitively bid out. ODNR Aquatic Education program has sent us an email notification of approval for a kiosk, stocking the pond, the Passport to Fishing Program, pond plants; we are waiting for official agreement documentation. The United Way that will be used for the skatepark, we are awaiting word.

The Interact for Health Grant LOI is due May 1; Williams advised that she would like to ask \$10,000.00 as a match for that grant. We would also like to plan some new play areas. We could get up to a \$50,000.00 grant.

McKibben moved that we spend the \$10,000.00 towards a Master Plan and the Park improvements, Popp seconded, motion carried.

Williams reported that we have, so far 39 banners.

Williams reported that the only parties interested in the Park Logo Contest was the Experiential Academy, they want to take in on as a project. Williams is meeting with them next week.

Popp updated us with the meeting with the Commissioners March 31 for funding, Williams gave the presentation to the County Commissioners, it went well but it is hard to read what the outcome will be.

Williams reported that we have asked for five people for the TANF summer employment program.

We have to date 80 shelter reservations. Last year we had over 250 total.

Williams advised that there are no plans for fireworks for the 4th of July. The Friends of the Parks, who did them before, have disbanded. It costs around \$17,000.00. We need to go public and have a newspaper piece maybe someone or organization may come forward.

Butcher went into New Business, the Financial Update: Williams reported on two items we needed a motion on: McKibben moved that we accept a \$200.00 donation from the Beta Sigma Phi Sorority for flowers and flower pots, seconded by Popp, motion carried. McKibben also made a motion to move a supplemental appropriation to 540.430.5277 to "Grant Match – Nature Works #Clip017" of \$2,670.00 from the Recreational Fund (this is the 25% match from the General Fund). The motion was seconded by Popp, motion carried.

Williams made the Athletic Coordinator Update for Jody Drake who was working a ball game, we have had 260 players and 19 teams' sign up for Soccer; 460 players and 38 teams for Baseball, softball; and registration is now ongoing for adult softball, volleyball and a new basketball league. This is more participation then we have ever had. We are going to be looking at doing on-line registrations. Jody Drake has made a great difference in this process.

Williams reported on the Concession Plans for 2014 Cindy Bowman wants to do it again this year.

Williams reported on the Maintenance Update, the security lighting at Fife Ave Maintenance Building is done. The Fife Concession restroom building is done. We are working with

Oberfields on the proposed retaining wall near pond parking lot. Work is planned on the trees near the tennis court and basketball court. Pond "muck" work will be on the 20th. We will be planting a tree purchased by Rails to Trails, at the Mulberry entrance to the Peace Path in dedication of Pat Gentile. Master Gardeners want to do a demo site of a "Food Forest". Williams is working on policy regarding preparing fields for non-rec programs.

Williams reported that Mary's pickup truck that she uses is in bad shape and we are going to need to do something else, we may net a couple thousand dollars from this year's banner program, we are going ahead and looking for a replacement ATV to use for field work.

Williams had already gave a status update on TANF workers, the Friends of the Parks want to do one more project, a light out front and then they will cease operations and dissolve.

At this point Williams took the board around the playground equipment and gave a visual demonstration of what is considered unsafe on the playground equipment and what we can do about it.

Official meeting lasted 1:12:08.

At 7:21 PM we went into Executive Session to discuss personnel matters.

At 7:25 PM we went out of Executive Session.

McKibben moved for Adjournment, seconded by Popp, motion carried.

The next regularly scheduled meeting will be at 6:00 Pm May 5, 2014 at the Wilmington City Building.

Thank you for your webcam presentation last night concerning the Southeast Community Park planning and development that covered the project from its concept phase to its present stage, and the insightful discussion that followed.

During post presentation, in discussion with the Southeast Community Park neighborhood resident committee who was on hand last night to give the Park Board their feelings about the park and project, we came to the conclusion that:

Due to budgetary restraints, prior allegation of available funds, employee and volunteer time commitment needed to mandatory city insurance carrier safety liability mitigation on existing equipment, and project volunteer development fatigue; we are not prepared to go forward with the "Tire Climber" project this season.

But the project is not being taken off the table. We just cannot go forward with it at this time. Perhaps in the future, the committee wanted to finish what we have on hand and see how it is received by the neighborhood.

You have been a great asset to our community and we sincerely thank you and look forward to future projects with you. Keep in touch.
