6-foot Galvanized Chain Link Fencing will include the following: 2" x 8' sch. 40 Line Posts; 1 5/8" sch. 40 top rail; 2 1/2" x 8' sch. 40 Terminal Posts; 6' 9 gauge finish wire; #7 tension wire; All posts shall be set in concrete.
