H. NEW BUSINESS

1. PZB 25-09 – Consideration for a softball training facility focused on providing expert-level batting and pitching instructions for youth and high school athletes within the Business Park (BP) District. The proposed softball training facility will be located at 935 Carney Court, Antioch, Illinois 60002, and the Property Tax Number is 02-08-405-043.

Attorney Vasselli read aloud the staff report. The applicant is proposing an indoor softball facility, and the proposed site is zoned "Business Park". Training facilities are not specifically mentioned under "Business Park" zoning as an allowed use. However, recreational uses are allowed. Therefore, the applicant is requesting a Special Use. Attorney Vasselli continued to review the findings of fact and advised that staff recommends approval of the Special Use.

Commissioner Madigan asked if there was an existing gym on Carney Court that obtained a Special Use. Chairman McCarty explained that a Special Use was previously passed for a weightlifting facility to open on Carney Court, but the applicant ended up not opening the facility. He added that there is a gymnastics facility in the area.

Commissioner Turner expresses support for the proposed softball facility.
