ADMINISTRATIVE REPORTS

May 12, 2015

Mr. Rowan offered an update about the upcoming meeting dates. There is no work sessin in June, July or August. For the June 2, regular meeting, the CIC will meet at 5PM, the Trustees at 5:30PM, the FAC at 6:30PM and the focus group at 7:30PM.

Mr. Meloy said they will recognize the graduating seniors from the Driving Angels program at the May 26, 2015, meeting. There are eight who have served for served four years.

Mr. Meloy said that we have begun a partnership/grant through Children's Hospital Medical Center, Buckle Up for Life. This is to further educate on safe driving and we have received 60 car seats.

Chief Denney said there was a child struck by a vehicle on Banning Road. A citizen quickly performed CPR, saving the two-year-old's life. We have found this citizen and hope to invite her to a future meeting.

Chief Denney said they have selected the body cameras and will have them on the street in next few monthes.

Mr. Birkenhauer said that we have so many restaurants in Colerain. The Health Department has issued their top 10 most violations and none of our restaurants on are in that group. He said that TAG's received the Clean Kitchen award.

TRUSTEES' REPORTS

Mr. Deters said the Township's Memorial Day ceremony will be May 25 at 10:30AM at the corner. He commended Terri Graber and the staff of TAG's Café.

Ms. Rinehart said that this is Police Week and she encouraged everyone to thank them for their service.

Mr. Ritter said that one of his roles is on the Hamilton County Emergency Management Agency. The agency has a new director, Nick Crossley. He invited Mr. Crossley to approach the Board and offer a presentation, which is Attachment 1 to the minutes.

A citizen asked about the Agency's budget and employees. Mr. Crossley said the budget is a half million and they have three employees.

Mr. Ritter said that the operations center is very impressive, with robust communications. He thanked Mr. Crossley for coming tonight.

CITIZEN ADDRESS

Mendo Janakievski said that two weeks ago he was charged by pit bulls. He said he called police and they arrested the owner, but the dogs remained on the property. His tenant has been charged by the dogs three times. He said the SPCA failed to do anything and asked what the will Township do.

Chief Denney said that our vicious dog ordinance was ruled unconstitutional and revoked. He will check with the SPCA, as they have mutual aid agreements with townships.

Mr. Janakievski said he is trying to prevent a tragedy from happening.

Mr. Deters said that we asked for restrictions on animals and had many people here opposing it.

Mr. Janakievski said it's not the animal, it's an owner problem.

Mr. Deters asked about the protocol for a dog bite.

Chief Denney said that violators can be cited with failure to control. He said that he wishes we had more tools

Mr. Birkenhauer said that three times we have tried non-breed specific legislation and 100s of people were protesting when we tried to do something. It's simply not possible to get laws passed as the state law doesn't allow.

Mr. Janakievski said the neighboring home also has zoning issues as there are four families living in the home with the dogs. There is drug dealing and he has called the police. How many people are allowed to live in a home? He said many properties in Northbrook are not maintained. Who implements the rules and laws?

Mr. Rowan said that we do recognize have nuisance and property maintenance issues. Do have full-time police officer assigned to this and implementing new software for reporting. He asked Mr. Janakievski to please talk to Chief Denney about the dog and give him the address so we can have these looked at tomorrow.

Mr. Janakievski asked if we want volunteers to list the violations and give them to us. He said he has been making complaints about the same properties for three years.

Mr. Rowan said the process, as laid out in Ohio law, is very antiquated.

James Blust owns the Realestate King, Inc. and he fixes up and rehabs properties. He is working on the home at 3431 Hollyglen Court and said there are problems with drug dealing activities at 3427.

Chief Denney said they made an arrest in that area last week.

Mr. Blust said that he is very concerned about drug activity in the area. He can't rent this house to a family in good conscious.

Mr. Deters said there is a problem with the decline in housing stock. He said there is a big chunk of landlords who just take the rent and there's no investment in the community. The Township is turning a corner on this now, with resources to the police for this. Mr. Deters said he is glad Mr. Blust came to be heard.

Chief Denney said that we are working on the DEA task force and we need people to give us information to allow us to take action.

Jim Acton said that some may not agree, but this is how he feels. He asked the Board, "What tells people who we are as a Township?"

Mr. Ritter said the Memorial Plaza announces our community and shows we honor veterans, police and firefighters.

Mr. Acton said the southwest corner of Colerain and Springdale has had many names and uses, and is still called multiple names. Kevin, Frank and he worked

many Fridays to make this what it is today. Citizens have purchased bricks and pavers, many times to honor those loved ones who have passed. He asked the Board the last time they were there.

Mr. Deters said he was there yesterday.

Mr. Acton said that we are purchasing new equipment, all to support our great township. Tax dollars are being spent wisely, but 60,000 people pass this plaza today. It's time to think about current and future condition of the plaza. He asked the Board to have tax dollars reallocated to support the continued upkeep of the plaza, as this is the gateway to the township.

Mr. Acton said the Memorial Day ceremony will be Monday, May 25, 10:30 AM, at the Gateway. Mr. Deters said that we will also dedicate the Purple Heart Memorial.

PRESENTATIONS

COMMUNITY RESULTS SURVEY - DR. LAMBERT, NKU

Dr. Lambert said that two students are with him tonight. He said that the survey results are overall very good news for the Township. He presented the results, which are attachment 2 to these minutes.

Mr. Ritter said the comment about dislike of taxes seems to conflict with interest in an increase.

Mr. Birkenhauer said that respondents were dissatisfied with the condition of roads, but not supportive of increase.

Dr. Lambert said there were not many against supporting, but they would tend to get indecisive at the mention part of specific funding.

There was a question from an unidentified citizen about roads vs. township streets and under whose responsibility each roadway falls. Mr. Birkenhauer

Mr. Birkenhauer said the question was worded to indicate it was about township streets.

Mr. Acton said that 127 people aren't very many.

Mr. Birkenhauer said that statistic sampling is a science and we feel confident this is one of the best sampling methodologies we have seen

Dr. Lambert said that we wanted 280, but were not able to reach people. Still, 90% confidence rating is very good.

Mr. Birkenhauer said the sample is from the voter registration list.

Dennis Mason asked why the respondents were in favor of the settlement with Rumpke.

Mr. Birkenhauer said they didn't probe that much, just yes/no/undecided. They didn't mention the monetary part.

Mr. Rowan also thanked Dr. Lambert and his class. This is one tool in the toolbox, to get information back to guide further conversation.
