#### **OPENING OF MEETING**

Ms. Rinehart called the meeting to order at 5:30PM. All Board members were in attendance.

## **EXECUTIVE SESSION**

Mr. Rowan requested the Board enter Executive Session for the purpose of discussing the employment and compensation of public employees and pending litigation.

At 5:31PM, Mr. Ritter made a motion to enter Executive Session and Mr. Deters offered the second. No discussion and the roll was called:

Mr. Deters. "Aye"

Ms. Rinehart. "Aye"

Mr. Ritter. "Aye"

Ms. Rinehart reconvened the meeting at 6:02PM. Mr. Rowan said no decisions or actions were made in Executive Session.

#### PLEDGE OF ALLEGIANCE

All recited the Pledge of Allegiance.

#### **PRESENTATIONS**

#### NORTHWEST LOCAL SCHOOLS

Ms. Rinehart read an endorsement for the bond/operating levy.

Mr. Deters offered a motion to endorse the bond/operating levy and Mr. Ritter offered the second. The roll was called:

Mr. Deters. "Aye"

Ms. Rinehart. "Ave"

Mr. Ritter. "Aye"

Todd Bowling, superintendent, said he appreciates endorsement.

Mr. Deters asked about the tax reduction.

Mr. Bowling said that their 2005 cuts were very severe in terms of staff. He said this levy replaces an existing operating levy at a lower millage, with an overall reduction of .70 mills. This would save an owner of a \$100,000 home about \$4 per year.

Mr. Deters said we have some shared services already and will continue to work with the district. He wished them the best of luck with the levy campaign.

#### CITIZEN ADDRESS

Bernie Fiedeldey spoke to the Board in regard to the shooting range resolution. He asked if this noise is negatively impacting neighboring property owners and if this is all documented. He said we did not place this in the original noise resolution, because we didn't want to get in to monitoring. He asked about Ohio law and what determines shooting ranges. Is this just a target in the back yard? Is the Board trying to suppress our 2<sup>nd</sup> amendment rights?

Ms. Rinehart said this would not apply to individuals. The whole point is to give the officers an amount of acceptable noise. We already have the machine, a decibel meter. This way, it's not up to the officer to determine by ear if something is too loud, we can read what the meter says. Mr. Meloy will speak more about this later in the meeting.

Mr. Fiedeldey said that we must have someone in mind about this.

Mr. Deters said that we've not voted on it.

Jeff Erdman is the president of Southern Ohio Dog & Game, which has 215 acres in western Colerain Township, with 1000 members. They were incorporated in 1931. He said they have a 50 yard rifle range, trap and skeet ranges. He said that under this proposal, owners are responsible for sound measuring. How many needed measuring devices are needed for 215 acres? How loud is 85 or 90 decibels? A power mower is 96 db, a chain saw 120 db. He said he learned about this proposal yesterday and it should be read a minimum of two times. He said they work closely with Ohio division of wildlife and can have someone here next month to discuss this. He said it seems they are trying to stop shooting firearms in the township.

Ms. Rinehart said the police would see if they are in violation, measuring at the property line. Of course, the Board is not trying to limit any one's rights to own or use a firearm. She said that we will review the definition of shooting range.

Bruce Peirano said he had some of the same concerns as the others and spoke with Mr. Meloy today. He said issues like this need to be vetted far better, with what it will or won't do.

Denny Mason said he is the vice president of the Dog & Game. He said he spent most of afternoon with ODNR. He said the regulations ODNR has written are for their own ranges, on their own property. He said there have been no problems with ranges, no complaints. He said the problems with are with people shooting within confined areas, 1 or ½ acre lots.

Jane Coleman asked for an update on the house on Poole Rd. She said the excavator left, but the house is still there.

Mr. Birkenhauer said we have a hearing on November 2 with Judge Beth Meyers, which we have asked to move earlier. He said we are equally frustrated with this process.

Mr. Deters said the Board was pretty generous with the homeowners and then they sued us.

Rich McVay said the Board should table the shooting range item and do more study. It's a complex process to monitor the sound.

Mr. McVay spoke about the Board's strategy for road improvement. He said that don't have a road strategy. They are making statements that we need levy, but we don't have model of how to get road work done. \$1.5 million won't go too far. He said that we have a cost disparity with Butler County and we need to talk to people who understand paving.

Ms. Rinehart said that Mr. McVay has spoken to both Mr. Lang and Mr. Birkenhauer. Mr. Lang has said there are processes for determining what streets will be repaired next. This is a strategy. She said we can't be proactive because we don't have funding. We must be reactive since don't have the funding. Butler County is using an inferior product.

Mr. Birkenhauer said they are comparing rural roads, without curb and gutter, with our township streets. The most expensive part is curbs. Mr. McVay's benchmarking is flawed. Mr. Lang has spoken to him and given him many documents.

Jim Acton spoke about police department and availability of crime statistics. He knows that we use the on-line website, raidsonline.com. He cited some crime numbers he said came from the website. He said that other residents are interested in this information, but don't have on-line access. The *Northwest Press* only lists to information through June. He said he is just asking for more information, like which was previously presented at the Township meeting by the Sheriff's Office.

Chief Denney said that he accesses the website daily and said the data Mr. Acton read is incorrect. Chief Denney said the information is sent weekly via email to the *Northwest Press*. He offered to show Mr. Acton how to access this.

Mr. Acton said that he doesn't want this; he wants it announced in the public session.

Chief Denney said the statistics we formerly reported during the meetings told the citizens nothing about what they're doing to make our community safer.

Mr. Meloy said the sheriff's office produced that information and it's not a statistic he keeps.

#### **ADMINISTRATIVE REPORTS**

Chief Cook said they are taking a leadership role in community paramedicine pilot. This is a result of the professional efforts by our employees.

Chief Denney said that we have a partnership with the FBI, for active shooter situations.

Mr. Meloy said that the Public Safety Department is hosting an event on community relations, November 4, 2015, 6:30-8:00PM, at Community Center. This is "Just a Conversation" to begin talking about this issues.

Mr. Meloy spoke about the Community Health Collaborative and said that, though this, we are looking at the number and incidents of falls. He said that a firefighter is working on a master's degree thesis on falls and to develop a proactive approach to prevent falls. Of the 660 falls, 120 can be proactively addressed. Our effort can change the direction with elderly and falls, through follow-up with these folks.

Mr. Rowan said last week, members of the leadership team attended the Lean Ohio Bootcamp. We received a grant to cover the cost of this. The purpose was to learn about the lean program and process improvement through process efficiency. He said that we plan to send remaining three department heads in March. Chief Cook already attended.

Mr. Birkenhauer offered a presentation on development and said that 2015 is banner year for both public and private sector development. His presentation is Attachment 1 to these minutes.

#### TRUSTEE REPORTS

#### MR. DETERS

Mr. Deters said that on Saturday, we re-named fire station 109 in honor of Bruce Smith. He commended Chief Cook and his team for putting together a great event.

Mr. Deters said there seems to be a notion that items on agenda are just "pushed through." He said that if the Board hasn't voted, a decision has not been made. He said he takes everything very seriously and things are vetted. If he has concerns, he asks for more input and continue the vote. We listen to residents, as we have done on many, many issues. Saying otherwise is not well placed in fact.

# MS. RINEHART

Ms. Rinehart thanked Mr. Birkenhauer for his presentation. She said that we have been criticized for spending money to make things look pretty. Most of it is TIF money and there are only certain things we can do with it. Things like our name on the fence over the highway are not paid for out of general fund money. We have drawn a lot of business to the area. Outback Steakhouse and others are renovating, not just leaving. This is encouraging. She said we are looking

forward to moving the excitement south, bringing the area back to its former glory.

#### MR. RITTER

Mr. Ritter offered his thanks to Chief Cook for inviting him to the dedication for Chief Smith. Chief Smith is an icon of Colerain for his contributions.

Mr. Ritter said he wished to address something that's occurred over the past few meetings – the lies and half-truths out forth by a candidate. The problem with not saying anything is that lies not challenged become the truth. He said he relishes a fair debate with the facts, but Mr. Insco's comments are not based on fact. He said the Board made difficult decisions based on funding cuts from state, but never once advocated the sale of our parks. He said there were also attacks on Mr. Rowan. The receipts Mr. Insco showed from Mt. Airy Pony Keg are the commercialization of the Community Center to sell alcohol for rented events. He never took a trip to New York City. Yes, Mr. Rowan went to Las Vegas. That is an annual trip with Mr. Birkenhauer for the International Council of Shopping Center's annual convention, known as the "super bowl of retail." Mr. Rowan did travel to Disney, as he was accepted into their institute and attended their course in leadership development. Regarding the use of Township vehicles, it's not unusual for this to be provided. When the Board hired Mr. Rowan, they didn't hire a "friend." In fact, he had never met Mr. Rowan. People who Mr. Rowan has now hired are ones with whom he had a track record. Finally, regarding the Jag's steakhouse receipt: after a national search firm sent the Board an underwhelming candidate, a colleague of one of the trustees mentioned Mr. Rowan's name to them. Mr. Ritter, Mr. Deters and Mr. Rowan and their wives went to dinner with this person and his wife as a "thank you" for referring Mr. Rowan to us. Mr. Ritter said that the Board could have charged the entire dinner bill to the Township, but instead they paid for their own dinners themselves. The Township only paid for the man and his wife who was their guest. He said this misinformation is a question of credibility.

A man rose from the audience and said it's not appropriate time to say things about Mr. Insco. There is too much animosity within the township.

Mr. Ritter said Mr. Insco read a prepared text, then left.

Ms. Rinehart said that Mr. Insco is the one who things all railed up.

Mr. Ritter said he finds it petty and aggravating. He can't stand here and hear lies because people's reputations are at stake.
