### **OPENING OF MEETING**

Ms. Rinehart called the meeting to order at 5:00PM. All Board members were in attendance.

#### **EXECUTIVE SESSION**

Mr. Rowan requested the Board enter Executive Session for the purpose of discussing pending litigation and the employment and compensation of public employees.

At 5:00PM, Mr. Deters made a motion to enter Executive Session and Mr. Ritter offered the second. No discussion and the roll was called:

Mr. Deters. "Aye" Ms. Rinehart. "Aye"

Mr. Ritter. "Aye"

Ms. Rinehart reconvened the meeting at 6:03 PM. Mr. Rowan said no decisions or actions were made in Executive Session.

#### PLEDGE OF ALLEGIANCE

All recited the Pledge of Allegiance.

#### **PRESENTATIONS**

#### **WE THRIVE**

Dan Meloy presented the program's year-end report; his presentation is Attachment 1 to these minutes. He introduced members of the collaborative, including Township Human Resources Director Emily Randolph, Colerain Police Lt. Jennifer Sharp and Kimberly Chelf, MPH, CHES, Health Educator Hamilton County Public Health. Paramedic Mindy Antolini's master's degree thesis is on fall prevention and we will integrate her work into our procedures. Our QRT was recognized at the We Thrive event as a standout program.

#### **EVENTS COMMITTEE - 2015 TASTE/2016 PLANNING**

Emily Randolph presented information about the Summer Events Committee; her presentation is Attachment 2 to these minutes.

## December 8, 2015

Mr. Rowan offered his thanks to Mrs. Randolph and the committee. He acknowledged the large amount of staff time taken away from day-to-day responsibilities as well as the personal time sacrifices the staff made to work on the event. He said we have the challenge to have more volunteers and community involvement. He said there would be an additional cost if we want to have a 4<sup>th</sup> of July event. We would need additional sponsors or donations.

Mr. Deters asked about having just fireworks, without associated vendors.

Mrs. Randolph said there was a suggestion to have food trucks, but the challenge is the electrical requirements. She said the cost is \$13,260 for 30 minute show and we need 16 volunteers. We are still challenged with police protections and shutting down Springdale Road.

Mr. Deters said that many residents miss the fireworks and he would be interested in exploring it.

Mr. Rowan said that we could also consider an alternative site. He said there is a possible partnership with Pebble Creek. He said the Summer Events Committee is a separate organization with a separate board. There is no action from this Board needed unless they want to provide funds.

#### **ROAD & FUNDING STRATEGY**

Mr. Rowan said that our road repair strategy has been reactionary in the past, but it is important to be proactive if we going to ask the community for support. Mr. Rowan offered a presentation, which is Attachment 3 to these minutes.

Mr. Ritter said 2012 is the last time we participated in SCIP funding program. He said it's hard to get funding because need to put up matching funds.

In response to Mr. Ritter, Mr. Rowan said that in 2015 we paid \$375,000 for the Philnoll work, which is a minimal investment.

Mr. Rowan said that as we do Township streets, we may be able to repair or replace sidewalks and driveway aprons at the same time, with residents paying for or being assessed for the costs.

Mr. Ritter said the budget management slide is the essence of why he supports the levy. We didn't ask for a levy in 2011, instead, we worked hard to tighten the budget before asking for a levy. We have made the necessary decisions to get to this point. Now, we are taking our own medicine and using taxes as a last resort, not first.

Mr. Ritter said the presentation was well done and connected a lot of dots. He said we are dealing with facts and not red hearings.

Mr. Deters said this decision has been years in the making. The budget situation has been making us accountable and run like a business, to come to the voters with these decisions. He said there is no shame in going to the voters and asking them, "what do you want now?" He said is very open to discussion with residents.

### **CITIZEN ADDRESS**

Bernie Fiedeldey asked if the fire is still going on at Rumpke. Is this a public nuisance? Will the Board appeal the case? Is the Hughes Road vacation party of the consent decree? He said the consent decree didn't cover illegal discharge of their odors. He said this could work if they would follow what they're supposed to do, but we allow them to get by with it. The acreage they have is about 1.5 square miles. This area will never be useful to this community in the future, even when we're all dead and gone. We still have issues and this landfill is a cancer on this community. Regarding the levy, he said that balancing the budget is a monumental task. He said that we need to be prepared to address zoning complaints and we should have township employees report any violations.

Rich McVay thanked Director Meloy for his work on the We Thrive initiative. He offered his thanks to Mr. Rowan for the information about the road strategy. He said that even though he is quoted in the presentation, we have different ideas of what to do now. We still need to spend more wisely before asking for more money. He asked if the police fund has paid back the general fund for the barn. He said he doesn't believe we have a road plan and the levy language is vague. Regarding the consent decree, it is bothering to him that Township standards for zoning are not required by the judge. We are expanding a landfill that's on fire, out of control. Leachate is permeating the surface. Odor complaints are going

up. If they expand, Rumpke can use current technology and practices. Residents have a right to be angry with trustees, commissioners, OEPA, for odor. This is a failure of leadership.

Mr. Deters said that it's off the wall to say that we've failed. We have done what he's advocated for.

Ms. Rinehart said Rumpke is a private business and they have the right to operate within zoning. We can't shut them down, we can't file other lawsuit . We have fought them for six years in the courts. The odds of getting this overturned are slim to nothing.

Mr. Ritter said that Mr. McVay is placing all responsibility on the Board. He has never thanked us for fighting for 10 years.

Bruce Peirano said that as a health professional, he was looking at all the data and Rumpke is within limits. He also looked at the decree and feels the Township shouldn't waste more money on litigation. He said the decree is very good, compared with what the Rumpke could do. It's a fair settlement. He said it's not a fire, but an underground reaction. Rumpke is well-ranked with how they work. He said this is a case of "not in my back yard," but waste must go somewhere. This decree is the best the Township can get.

Delores Thomas approached the Board to thank everyone for the attention to the problems in her neighborhood. Since October, there have more police riding in their cars. Visibility has made a difference. She said there is less trash being thrown. She offered her thanks.

Chief Denney said that she has been a great help to them.

Terry Stephens said he supports the road levy, as he has seen his own street deteriorating. He doesn't want to see Colerain Township continue to slip. It's time for a fix. Now we need to sell the idea and enlighten the citizens.

Jim Acton said that as 2016 is facing us, he has some questions for the board. Regarding the issues of transparency, he said that citizens need more understanding what's going on. He said that for years, we opened the meeting with a prayer and asked why we haven't for the past two years.

Mr. Barbiere said the US Supreme court said this is unconstitutional

Mr. Acton thanked the We Thrive program group and said they are on the right track, and need to keep pushing. He said that on the Waycross recordings, most voices don't come across. He said he will represent citizens and will say it like it is. He asked about the profits for the park passes. Mr. Rowan said this was \$40,000 to \$45,000. He said that we lost the JEDZ because of our own fault, not Rumpke spending. What's the plan now for the levy?

#### **ADMINISTRATIVE REPORTS**

Mr. Meloy said that the police department has repaid for the barn.

Chief Denney said they are looking at beginning an Explorer program, via the Boy Scouts. He said the FOP offers associates degree tuition to those who complete the program.

Mr. Rowan thanked the employees for their work in 2015, to advance our cause, to deliver best in class service to our residents.

#### MR. RITTER

Mr. Ritter said that the Board has completed Mr. Rowan's annual appraisal and evaluation. The Board highly values his leadership and they are grateful for having him. Mr. Rowan has met or exceeded expectations.

## Selection and Hiring Process for Fleet Mechanic
