Mr. Inderhees made a statement regarding the shooting this weekend on Capstan.

Mr. Inderhees asked everyone to join in a moment of silence for Autumn Garrett and the unborn baby lost in the incident in Northbrook.

#### **PRESENTATIONS**

## Colerain Township "Give Back Day" Presentation

Ron Henlien, director of corporate/community partnerships for People Working Cooperatively presented about the partnership to help on our community on September 9, 2017.

Scott Sollomann provided an update on the Brehm Road property nuisance.

#### **CITIZEN ADDRESS**

Linda Carl thanked the Board for the help with the Brehm Road nuisances. She asked about an update to the noise ordinance to expand beyond music.

Mr. Meloy said they attack the issue individually with each incident. Her situation is different.

Stephanie Wright spoke regarding the hiring of Geoff Milz. She said the Township failed to supply notice for this meeting and the minutes appeared later. There was no resolution for this hiring. She said this is incompetency.

Kathy Mohr said Mr. Acton made points about treatment of the citizens at the last meeting. She said she was verbally attacked. Ms. Mohr rebutted Mr. Crum's comments about her and Ms. Wright at the previous meeting.

Mr. Inderhees said Ms. Mohr is allowed to make comments about items on the agenda only. When Ms. Mohr did not stop, Mr. Inderhees had her removed from the meeting by a police officer.

Keith Miller said the first amendment guarantees freedom of speech and the Board is stifling this.

Janie Hammon spoke about a tactic drug dealers are using, infrasonic sound. This is below 20 hz and travels through the body not the ear. She asked for the noise ordinance to be updated to include this.

Mike Parsons described an incident which demonstrate the pettiness of this board. He said his neighbor didn't get called last month because he signed in on the wrong form. He said he believes Board individuals are susceptible to prosecution under the Rico statute. There is clear collusion.

Bonita Sergent said she has been a resident 43 years. Her neighborhood is going down and down. She is doing all she can as a good citizen, but it's getting worse. She is worried an incident like the Capstan shooting could happen in her

neighborhood. There are drugs deals and ODs in the neighborhood. She said the neighborhood is getting a reputation and the wrong people are seeping in.

Mr. Inderhees said the police are working hard on incident.

Mr. Ritter suggested she start a block watch.

Mr. Insco said the more sets of eyes the better. He suggested she network with all of the neighbors. Persistence pays off! He said to report everything. He said there are far more good people in the community.

Rich McVay said that in 2010, the Sagebrush neighborhood needed to have sewers installed. The Board listened and told the residents that we can't use tax money for private property. Well, now the Board is giving CMHA \$800,000, subsidizing police coverage at the mall and spending tax payer dollars on businesses. Business should use their own money and not receive tax breaks.

Bob Thinnes said he is running for trustee. He thanked police and fire for their work Saturday. He shared information about the broken window theory. He said customer service is paramount and the staff should answer the phone within three rings.

Jim Acton thanked Chief Denney for his help with a clean-up problem. He apologized to Mrs. Wright for what Mr. Crum said at the last meeting. He asked we have a letter of credit for the TIFs. This is \$10 million in debt. What if they pull out? He said the recording's audio quality is such that one can't be heard from the microphone.

Dennis Yavorsky said his daughter was attacked at a pub in the Township and the police department did an inadequate job of investigation. He said it doesn't take a clairvoyant to see where the Township is going. He said we have inadequate resources to enforce the law.

Bernie Fiedeldey said that via the CIC, the Township gave tax payer money to the Chamber of Commerce, which is not a non-profit. He asked about the statutory right for financing the Chamber of Commerce. He asked the Board to follow the law and seek an opinion from the Ohio Attorney General.

Mr. Ritter said he'd favor that.

Mr. Fiedeldey said we should hire deputies and put them in Northbrook. Let them take care of business.

Linda Rothwell asked if we received a response from Kroger. She asked what the Rumpke TIF means. She said the houses are on a vacated street and we lost that property tax as residential. She said she is a Republican and not an Insco crony. She said citizens have the right to come ask questions and get answers, about how things are done with money.

Steve Crum said need we more handicapped parking spots out front. He asked about the number of public records made since the last meeting and how much time they took to fulfill.

Lora Dakin said, in light of events in Northbrook this weekend, we do have a core neighborhood group to work with the police department. She said they are very saddened over the events, but not going to let it stop us to pull back our neighborhood. They will look for solutions and are trying to pull the community together. She said they hosted an Independence Day home decorating contest. They will have an event for kids on July 22.

Mr. Ritter offered a motion for a recess and Mr. Inderhees offered the second. No discussion and the roll was called:

#### <u>ADMINISTRATIVE REPORTS</u>

Chief Denney said they have been dealing with the infrasonic sound issue for a while and have contacted NIOSH. There is not much we can do. He said he understands the citizens' frustration with crime and the Police Department feels the same way. He said a lot of time and effort goes into this, but it seems the rights are afforded to the criminals. He said we are in tune with drug issues. With our CARE program, QRT and CALEA accreditation, it's clear that the

Department does more that just drive down the street. He said we've had a 32% reduction in violent crime and total crime is down 16%, but arrests are up.

Mr. Milz said tonight the Board is giving notices to extend the TIF already in existence.

Mr. Ritter offered a TIF 101 primer.

Mr. Meloy said we have had an infiltration of students from outside the district attending NWLSD. We found that there were 80 students using tax dollars to go to school for no money by using an address in Colerain to go to our schools.

Regarding students walking on Joseph Road, Mr. Meloy said we do our best with this. We are acquiring easements and land to put in sidewalks.

Mr. Meloy said we are a member of the Chamber. The \$650 annual membership fee saves us \$20,000 on our employee healthcare.

Regarding public records requests, Mr. Meloy said we have had 25 requests by three people since the last meeting, totaling 35-40 hours of work.

#### TRUSTEE REPORTS

Mr. Inderhees said the meeting where the Board hired Mr. Milz meeting did happen and there was proper notice. He thanked the Summer Events Committee and fireworks crew for a great event on July 1. He said the Pray Hope Believe 5K race. for pediatric brain cancer research was July 4. This event raised \$47,000 this year. Mr. Inderhees addressed the questions about why we have police officers at meetings and said especially after the attack on DC lawmakers, we have a need to say safe. He offered condolences to victims and to first responders after the Capstan Drive shooting. He asked everyone to keep the investigators in prayer as they work hard to bring justice. Mr. Inderhees said there has been a change in the law and we are now allowed to accept sponsorships for the CERKL e-newsletter and website.

Mr. Insco welcomed Mr. Schwartzhoff back to the Township. He thanked Jim Love, who is the face of the Township as our public information officer.

Mr. Insco thanked Diefenbaker's Greenhouse for the donation of flowers, which were planted at the Township Administration Building and our Colerain Township Memorial site, Colerain and Springdale Road.

Mr. Insco also thanked Chief Denney for his assistance with solving the traffic situation in the parking lot near Cheddars restaurant.

Mr. Insco acknowledged Anthony, who became an Eagle Scout.

He also acknowledged Bill Flowers, who will be 80 next month and still works for post office.

He thanked Steve Yosafat for his work on the Thimbleglen entrance to Colerain Park.

Mr. Insco thanked Dan Schulte for fixing the divots at the end of driveways.

He said the fireworks were incredible and thanked the Girl Scouts who picked-up trash after event.

He said the Hope Pray Believe Foundation hosted the 5K race on the 4<sup>th</sup> of July. He thanked the administration, Trustees, Mr. Meloy and Mrs. Molter for their support.

He said he has made no records requests.

Regarding the Joseph Road sidewalks, we are waiting on the right of way survey.

Mr. Insco listed some upcoming events.

He said we have had our first homicide of the year and there is a GoFundMe for the victim. We can't let an event like this define our community.

Mr. Ritter spoke about the Capstan Drive shooting Saturday night and extended his condolences. He said every community has a tipping point and this could be the start of one. He said we should elevate the tone of the conversation and come together, move forward together. For the Kroger TIF, we are not on the

hook and have no obligation to make any bond payments until the increment is created.

### **PUBLIC HEARING**

## **ZONING TEXT AMENDMENT – WALL & HIGH RISE SIGN REGULATIONS**

Mr. Milz said the Zoning Commission recommended 5-0 to approve the text amendment to modify Sections 15.6, 15.8 and 16.2 of the Zoning Resolution. This modified language would provide for the removal of the four-foot height restriction on wall signs and the allowance for wall signage on any side of the building regardless of whether it faces a right-of-way. Allowable sign area would still be based on the total building frontage on the right-of-way. This text amendment would also prohibit high rise signage. This text amendment was initiated by the Board of Trustees on May 9, 2017, was unanimously recommended for approval by the Hamilton County Regional Planning Commission on June 1, 2017, and slightly modified and unanimously recommended for approval by the Zoning commission.

#### **2018 TAX BUDGET**

Mrs. Randolph presented the 2018 tax budget. She said the annual budget process includes a review of annual operating expenses, as well as the discussion with Department Heads on upcoming capital needs. Each July, the Township presents the upcoming years tax budget to the Board of Trustees. Additionally, the 2018 tax budget preparation included individual meetings with

each of the Township Trustees to review Township and Departmental expenses and revenues.

She recommended approval of the 2018 Tax Budget in the amount of \$30,955,575.30.

Mr. Meloy said today is a presentation and there is no spending authority with this document.

Mrs. Randolph said they thought about how we spend every dollar and reviewed each line item.

Mr. Ritter said this was the best budget presentation in twelve years. He said you can't get more transparent. He said the general fund is structurally aligned.

Mr. Inderhees said road resurfacing is separate from rehabilitation, which is typically SCIP-funded.

## Approval of Resolution - Amendment Drone Registration

Mr. Meloy Recommend the Board of Trustees approve Resolution 33-17, "Resolution Amending Rule 23 (Drones and Other Aircrafts) of the Colerain Township Board of Trustees' Park Rules and Regulations," amending the 2016 "Drone Registration" rules. Colerain Township's drone guidelines have been invalidated by a recent United States Court of Appeals, District of Columbia Circuit ruling, Taylor v. Huerta, 856 F.3d 1089 (2017). In Taylor, the court held that Federal Aviation Administration ("FAA") lacked statutory authority to require owners of small unmanned aircraft operated for recreational purposes to register with the FAA. We requested a legal opinion from our Law Director on the Taylor decision and its impact on Colerain Township drone registration rules. It was recommended that the current Colerain Township drone rules, "Resolution #16-10, Rule 23 – Drones and Other Aircraft", be amended to remove the language regarding a person's requirement to register their drone with the FAA.
