RESOLUTION NO. 01-67

RESOLUTION AUTHORIZING CONTRACT WITH DONALD A. LOCASTO, M.D.,  
AS PHYSICIAN MEDICAL DIRECTOR OF DEPARTMENT OF FIRE & EMS

WHEREAS, the Board of Trustees does hereby determine that it is necessary and advisable to retain the services of a physician as a medical director to assist the Township to meet its obligations Ohio Revised Code section 4765.12 for implementation of peer review, quality assurance programs, and other requirements designed to improve the quality of services provided by the Colerain Township Department of Fire and EMS; and,

WHEREAS, Board of Trustees does hereby determine that is necessary and advisable to retain an EMS Medical Director as an independent contractor to provide oversight and counsel in delivery of the emergency medical services ("EMS") provided by The Colerain Township Department of Fire and EMS in basic life support and advanced life support situations.

NOW, THEREFORE, be it RESOLVED by the Board of Trustees of Colerain Township, Hamilton County, Ohio that:

1. The Board authorizes an agreement with Donald A. Locasto, M.D. as an independent contractor, appointing him as Physician Medical Director of The Colerain Township Department of Fire and EMS program, to assist the Department in meeting its statutory obligations under Ohio Revised Code Section 4765.12, upon terms and conditions not inconsistent with the following:

- a. Effective Date, Term, and Renewal. This contract shall be effective January 1, 2008, and shall have an initial term of one year. This contract shall renew automatically on January 1<sup>st</sup> of each subsequent year for successive terms of one year, until terminated by either party upon 90 days written notice to the other.
- b. Payment. The EMS Medical Director shall be paid \$2,900.00 monthly for services rendered, on or before the last day of each month, commencing with the month of January, 2008. In the event of unforeseen circumstances which would require additional hours outside this agreement, the EMS Medical Director shall be compensated at the rate of \$100.00 per hour. Such additional hours shall be approved in writing by both the EMS Medical Director and the Administration of The Colerain Township Department of Fire and EMS prior to the additional hours being worked.

c. Services to be Provided. The Agreement shall specify the minimum number of hours per month that the EMS Medical Director shall, <sup>on</sup> site, riding with EMS crews, providing training to personnel, and performing other services, as may be deemed necessary by Chief of the Department of Fire & EMS.




