

**The Board of Trustees of Colerain Township, County of Hamilton, Ohio**, met in regular session at 7:00 p.m., on September 27, 2011, at the Colerain Township Administration Building, 4200 Springdale Road, Cincinnati, Ohio 45251, with the following members present:

Mr. Dennis P. Deters; Mr. Jeffrey F. Ritter, and Mr. Joseph R. Wolterman

Mr. Wolterman introduced the following resolution and moved its adoption:

**RESOLUTION NO. 56 -11**

**COLERAIN TOWNSHIP BOARD OF TRUSTEES**

**RESOLUTION FOR DISPOSAL BY SALE OF VEHICLES WHICH ARE OBSOLETE, UNFIT, OR UNNEEDED FOR PUBLIC USE (O.R.C. Sec 505.10)**

WHEREAS, Ohio Revised Code Sec. 505.10 authorizes the Board of Trustees to dispose of personal property, including motor vehicles, road machinery, equipment, and tools, which the Board finds by resolution are not needed for public use, or are obsolete, or are unfit; and

WHEREAS, Ohio Revised Code Sec. 505.10 (A)(2)(a) authorizes the Board of Trustees to sell by private sale, without advertisement or public notification, if the property to be sold is, in the opinion of the Board, \$2,500.00 or less.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Colerain Township, Hamilton County, Ohio:

A. The Board of Trustees finds that, in the opinion of the Board, the following vehicles are not needed for public use, or are obsolete, or are unfit, and that, in the opinion of the Board, each vehicle has a fair market value of \$2,500.00 or less:

1. 2000 Mazda Millenia – Vehicle Identification Number: JM1TA2210Y1615150
2. 1998 Cadillac Deville – Vehicle Identification Number: 1G6KD54Y8WU731614

B. Pursuant to O.R.C. Sec. 505.10 (A)(2)(a), the Board directs that the method of private sale of the vehicles listed above shall be by auction conducted by the Adesa Cincinnati/Dayton Auto Auction, 4400 William C. Good Blvd., Franklin, Ohio, and, accordingly, that said vehicles be delivered to that company.


