

**The Board of Trustees of Colerain Township, County of Hamilton, State of Ohio,** met in regular session at 6:00 p.m., on the 10<sup>th</sup> day of April, 2012, at the Colerain Township Administration Building, 4200 Springdale Road, Cincinnati, Ohio 45251, with the following members present:

Mr./Ms. Rinehart introduced the following resolution and moved its adoption:

**RESOLUTION NO. 14-12**

**RESOLUTION ELIMINATING POSITIONS OF  
PART TIME ZONING INSPECTOR AND  
FULL TIME ZONING DEPARTMENT LAND USE PLANNER**

WHEREAS, cutbacks in sources of funding for the General Fund have recreated a serious imbalance between receipts and expenditures in the General Fund; and

WHEREAS, the Board of Trustees has determined that it is necessary to take immediate action to avoid the anticipated deficit in the General Fund; and

WHEREAS, the Board has determined that is necessary to implement a reduction in force, eliminating positions from the Township's organizational structure, and to lay off the employees now occupying those positions, as set out below.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Colerain Township, Hamilton County, Ohio, that:

1. Effective April 28, 2012, the position of full time Land Use Planner in the Planning and Zoning Department, and both positions of part time Zoning Inspector in the Planning and Zoning Department, be, and hereby are abolished and eliminated from the Township's organizational structure.
2. Effective April 28, 2012, the employees currently holding those positions will be laid off from their employment with Colerain Township. The Board approves the placement of those employees on paid administrative leave through April 27, 2012.
3. This Resolution shall become effective at the earliest time permitted by law.
4. It is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in an open meeting of this Board, and that all deliberations of this Board and of any of its committees that resulted in such formal action were taken in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

Mr./Ms. Ritter seconded the Resolution, and the roll being called upon the question of its adoption, the vote resulted as follows:
