- 1.1 **SEALED BIDS** will be received by Colerain Township, Ohio **until 10:00 a.m., (local time) on Thursday, August 3, 2017** in the Administration Building, 4200 Springdale Road, Colerain Township, Ohio 45251, and publicly opened and read at that hour and place. Any bids received after this time will be returned to the bidder unopened.
- 1.2 **SCOPE OF WORK** to be performed includes the reconstruction of the center roundabout island at the end of Stone Creek Boulevard. Improvements include the removal of existing concrete surface and addition of cobblestone truck apron, landscaping, underdrain system, and sealcoating of Stone Creek Boulevard.
- 1.3 **IMPROVEMENTS** shall be constructed in accordance with the Contract Documents. Colerain Township reserves the right to reject any or all bids in accordance with the Contract Documents. The Colerain Township reserves the right to add to or to subtract from the contract quantities. Colerain Township also reserves the right to hold all proposals for sixty (60) days.
- 1.4 **PLANS, SPECIFICATIONS, AND CONTRACT DOCUMENTS** can be obtained from Colerain Township, 4200 Springdale Road, Colerain Township, Ohio 45251, Monday through Friday, **beginning Wednesday, July 19, 2017**. A fee of \$35.00, non-refundable, will be charged for each set of Contract Documents. Checks and money orders should be made payable to Colerain Township. Copies of the Bidding Documents may also be examined at the Dayton Builders Exchange and the McGraw Hill Construction Dodge Plan Room in Columbus.
- 1.5 **EACH BIDDER** is required to furnish with its proposal, a Bid Guaranty (10% of the Bid Amount) and Contract Bond (100% of the Bid Amount) in accordance with Section 153.54 of the Ohio Revised Code. Bid security furnished in Bond form, shall be issued by a Surety Company or Corporation licensed in the State of Ohio to provide said surety.
- 1.6 **EACH BID PROPOSAL** must contain the full name of the party or parties submitting the proposal and all persons interested therein. Each bidder must submit evidence of its experiences on projects of similar size and complexity.
- 1.7 **BIDDERS** must comply with the prevailing wage rates on Public Improvements in Hamilton County and Colerain Township as determined by the Ohio Bureau of Employment Services, Wage and Hour Division, (614) 644-2239.
- 1.8 **BIDS** shall be enclosed in a sealed envelope identified as **“Contract 17-2 Stone Creek Boulevard Roundabout Improvements”** and **MUST HAVE THE FULL NAME AND ADDRESS** of the bidder on the envelope.
