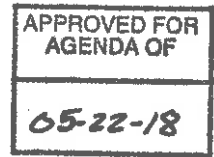

**MINUTE MAY 8, 2018**  
**REGULAR MEETING OF THE DEARBORN HEIGHTS CITY COUNCIL**

**18-159** The meeting was called to order at 8:18 p.m. by Council Chairwoman Denise Malinowski Maxwell.

**18-165** Motion by Councilman Abdallah, seconded by Councilman Muscat, to award the low bid to Allied Building Service to provide and install one York Predator 6.5 Ton HVAC Unit or equal at City Hall at a cost of \$12,305.00. Funds for this project were allocated in the 2017-2018 Budget. This motion also authorizes the Mayor to sign the agreement on behalf of the City and the Comptroller's Office to return the bid bonds to the unsuccessful bidders, as outlined in 7-A. Per Public Service Director Zimmer communication dated April 30, 2018.

**18-166** Motion by Councilman Muscat, seconded by Councilman Bazzi, to move to a study session for discussion and resolution with all parties involved, the agreement with the Dearborn Heights Public Employees Association effective July 1, 2016 through June 30, 2021. Per Mayor Paletko communication dated April 30, 2018.

**18-167** Motion by Councilman Muscat, seconded by Councilman Bazzi, to move to a study session for discussion and resolution with all parties involved, the Memorandum of Understanding with the Dearborn Heights Public Employees Association to settle Grievance 17-295. Per Mayor Paletko communication dated April 24, 2018.

**18-168** Motion by Councilman Muscat, seconded by Councilman Abdallah, to approve the request from the North Dearborn Heights Baseball League to hold their Annual NDHBL Opening Day Parade for Saturday, May 5, 2018 at 10:00 a.m., as outlined in Item 8-C. Per Mayor Paletko communication dated May 2, 2018.

Motion adopted.

**18-169** Motion by Councilman Muscat, seconded by Councilman Bazzi, to concur with the purchase of seven (7) Samsung Galaxy Tab S3 32 GB Tablets or equivalent, with the concurrence of IT to ensure they are compatible with City IT, at a present cost of \$519.00 per tablet, seven (7) Fintie Samsung Galaxy Keyboard Case and seven (7) 4 year accident protection plans to be used by City Council members. In addition, to add on to this order two (2) 25 Pack CF Memory Card Plastic Storage Jewel Cases to hold, store and protect the memory cards for the new Dominion voting machines. Also to authorize the payment of \$4,334.91, allowing for possible price fluctuations, as outlined in Item 9-A. Per City Clerk communication dated May 1, 2018.

**18-171** Motion by Councilman Constan, seconded by Councilman Abdallah, to authorize the Treasurer to enact interfund loans, if needed, at an interest rate of 2.10% per annum, between the Water-Enterprise Fund and General Fund for a maximum amount of \$1,750,000.00, as outlined in Item 9-C. All loans shall be repaid on or before September 15, 2018. Per Treasurer Riley communication dated May 1, 2018.

**18-172** Motion by Councilman Muscat, seconded by Councilman Constan, to modify the course of action authorized and approved by Motion 17-425 relative to the liquor licenses for the Warren Valley Golf Course. If Corporation Counsel Miotke determines that the ability to use the conditional liquor license may be delayed by entering into a participation agreement with Oneida Golf Services, Inc. or by seeking Liquor Control Commission approval of such a participation agreement, then the Administration shall not be required to either enter into such an agreement with Oneida Golf Services, Inc. or to seek Liquor Control Commission approval of such an agreement. In all other respects, Motion 17-425 remains unchanged, as outlined in Item 9-D. Per Corporation Counsel Miotke communication dated May 1, 2018.

Motion adopted.

**18-173** Motion by Councilman Abdallah, seconded by Councilman Bazzi, to concur with the replacement and rebuilding of the Justice Center security gates and for the Comptroller's office to issue a 50% deposit check in the amount of \$19,037.50 in June 2018 to International Controls and Equipment and the remaining \$19,037.50 to be issued upon completion, as outlined in Item 9-E. Funds have been allocated in the 2018-2019 Capital Outlay Fund. Per Police Chief Gavin communication dated April 23, 2018.

Motion adopted.

**18-174** Motion by Councilman Muscat, seconded by Councilman Bazzi, to concur with the payment to the State of Michigan for programming of 54 new portable radios recently purchased from Motorola, for a total cost of \$13,500.00. The payment will be deducted from the contractual services account, as outlined in 9-F. Per Police Chief Gavin communication dated April 10, 2018.

**18-175** Motion by Councilman Constan, seconded by Councilman Bazzi, to approve the Business License renewals for Applebee's, 26582 Ford Road, Buck's Pub, 23845 Warren, Dearborn Heights Moose Lodge, 27225 Warren, Denny's Gin Mill, 4901 S. Telegraph and First Mutual Auto, 6888 N. Telegraph, as outlined in Item 13-A.
