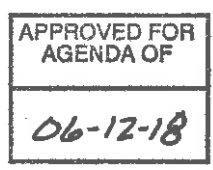

**MINUTES MAY 29, 2018  
SPECIAL MEETING OF THE DEARBORN HEIGHTS CITY COUNCIL**

**18-192** The meeting was called to order at 8:02 p.m. by Council Chairwoman Denise Malinowski Maxwell.

Roll Call showed the following:

**18-193** Motion by Councilwoman Hicks-Clayton, seconded by Councilman Bazzi, that the Agenda for the Special Meeting of May 29, 2018 be approved as submitted.

Motion unanimously adopted.

**18-194** Motion by Councilman Muscat, seconded by Councilman Constan, that the City Council adopts the General Government Fiscal 2018-2019 surplus budget in the amount of \$46,107,926.00 as outlined in Item 13-A.

Motion unanimously adopted.

**18-195** Motion by Councilman Constan, seconded by Councilman Muscat, that the City Council adopts the Library Fund Fiscal 2018-2019 surplus budget in the amount of \$2,258,594.00 as outlined in Item 13-A.

Motion unanimously adopted.

**18-196** Motion by Councilman Bazzi, seconded by Councilman Muscat, that the tax levy for the 2018-2019 fiscal year be set at 8.3167 mills as outlined in Item 13-A.

Motion unanimously adopted.

**18-197** Motion by Councilwoman Malinowski Maxwell, seconded by Councilman Abdallah, that 7.25 mills be levied to finance the voter approved Act 345 Fire and Police Pension Plan for fiscal year 2018-2019 in the amount of \$8,567,983.00 as outlined in Item 13-A.

Motion unanimously adopted.

**18-198** Motion by Councilman Abdallah, seconded by Councilwoman Hicks-Clayton, that the City Council levy an additional 2.1833 mills on the Taxable Valuation for financing garbage and rubbish disposal for fiscal year 2018-2019 as outlined in Item 13-A.

Motion unanimously adopted.

**18-199** Motion by Councilwoman Hicks-Clayton, seconded by Councilman Abdallah, that the City Council levy an additional 1.9568 mills on the Taxable Valuation of Public Safety, as approved by the voters of the City of Dearborn Heights for fiscal year 2018-2019, as outlined in Item 13-A.

Motion unanimously adopted.

**18-200** Motion by Councilman Wencel, seconded by Councilman Bazzi, that the millage approved for solid waste disposal by the electorate in May 2000, be levied at .9784 mills as outlined in Item 13-A.

Motion unanimously adopted.

**18-201** Motion by Councilman Muscat, seconded by Councilman Bazzi, that the City Council approve the 2018-2019 lump sum budget for the 20th District Court, in the amount of \$2,124,840.45 as outlined in Item 13-A. Salaries not to exceed amount specified in the budget.

Motion unanimously adopted.

**18-202** Motion by Councilman Constan, seconded by Councilman Muscat, that the City Council levy an additional .8989 mill to fund the City Department for Libraries including new improvements of library buildings as approved by the voters of the City of Dearborn Heights as outlined in Item 13-A.

Motion unanimously adopted.

**18-203** Motion by Councilman Bazzi, seconded by Councilman Constan, that the City Council levy an additional .9294 mill to fund the City Libraries as approved by the voters of the City of Dearborn Heights as outlined in Item 13-A.

Motion unanimously adopted.

**18-204** Motion by Councilman Abdallah, seconded by Councilman Constan, that the salaries of Administrative Assistant Laslo, Building and Engineering Director Sobh, Public Service Administrator Zimmer, and Recreation Director Grybel be increased by 10%.

Ayes: Councilman Abdallah, Councilman Constan.

Nays: Council Chairwoman Malinowski Maxwell, Councilman Bazzi. Councilwoman Hicks-Clayton, Councilman Muscat, Councilman Wencel.

Motion failed.

**18-205** Motion by Councilman Muscat, seconded by Councilman Abdallah, that the meeting be adjourned.

Motion unanimously adopted.
