Re: Alternative Daily Cover Bid Award

Laura, I've analyzed the three bids that were presented for the bid opening on September 27, 2012 in the Purchasing Conference Room. Below is the breakdown of the three submitted bids.

1. Landfill Solutions:

Cost per load of material \$191.04. This covers 9600 sq/ft.

2. LSC Environmental Products:

Cost per load of material \$446.25. This covers 36,000 sq/ft.

3. New Waste Concepts:

New waste Concepts is actually considered to be non-responsive due to the fact that their specification sheet, cover sheet and quote sheet all have conflicting cost, amount of coverage per/qf and number of bags required to complete a full mix. This conflicting information doesn't allow me to compute an accurate assessment of their product.

I'm recommending that LSC Environmental be awarded the bid. Even though Landfill solutions cost per load is less than LSC Environmental, it takes more than three loads of Landfill Solutions product to equal one load of the product from LSC Environmental Solutions.
