<u>Description of Project</u>	<u>Estimated Expenditure</u>
<b>FY13 4kV to 12kV Distribution Line Conversion</b> <i>This expenditure is convert two distribution circuits from 4kV to 12kV: Boys Club #1100 and portions of Westown #830 along Danville Road.</i>	<b>\$190,000</b>

<b>Wallace Substation Equipment Replacement</b> <i>This expenditure will replace aging equipment in Wallace Substation which was placed in service in 1974.</i>	<b>\$250,000</b>
