NOVEMBER 18, 2008**

**Mayor Ed Hagnauer called the regular meeting to order of the city council at 7:05 p.m.**

**MOTION by Whitaker, second by Eavenson to approve the city council minutes for the previous meeting on November 5, 2008. Motion Carried.**

**MOTION By McDowell, second by Kambarian to place on file the monthly report for Building & Zoning for October 2008. Motion carried.**
