## **ORDINANCE NO. 2025-40**

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF BUDA, TEXAS DECLARING THE CANDIDATE FOR COUNCILMEMBER AT-LARGE POSITION 1, MATT SMITH, UNOPPOSED; DECLARING MATT SMITH, ELECTED; CANCELING THE GENERAL ELECTION FOR COUNCILMEMBER AT-LARGE POSITION 1 TO BE HELD IN THE CITY OF BUDA, TEXAS, ON TUESDAY, NOVEMBER 4, 2025; REPEALING ALL ORDINANCES OR PARTS OR ORDINANCES AND RESOLUTIONS OR PARTS OF RESOLUTIONS INCONSISTENT OR IN CONFLICT HEREWITH; AND PROVIDING FOR SEVERABILITY.

WHEREAS, pursuant to Ordinance No. 2025-36 adopted July 16, 2025, a general election was ordered to be held on November 4, 2025, for the purpose of electing a Councilmember for At-Large Position 1; and

WHEREAS, pursuant to said resolutions and state law, the deadline for filing applications for places on the ballot and declarations of write-in candidacy for said elections has expired; and

**WHEREAS**, the City Council of the City of Buda, Texas, hereby finds and determines that the person whose name is to appear on the ballot in said election is unopposed.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BUDA, TEXAS:

**Section 1:** The facts and recitations set forth in the preamble of this ordinance are hereby found to be true and correct.

**Section 2:** The City of Buda, Texas, hereby cancels the general election for Councilmember At-Large Position 3 and Councilmember Single Member District A scheduled to be held on November 5, 2024, in accordance with Section 2.053(a) of the Texas Election Code. The following candidate has been certified as unopposed and is hereby elected as follows:

<u>Section 5</u>: <u>Severability</u>. If any clause or provision of this ordinance shall be deemed to be unenforceable for any reason, such unenforceable clause or provision shall be severed from the remaining portion of the ordinance, which shall continue to have full force and effect.
