WHEREAS, subject to the provisions of Chapter 2, Subchapter C of the Texas Election Code, the Board of Directors of Hays County Municipal Utility District No. 7B (the "District") has adopted an Order Calling Directors Election to be held on May 2, 2026 for the purpose of electing three (3) directors; and

WHEREAS, pursuant to Section 144.005 of the Texas Election Code, the deadline for filing an application to be a candidate for director of the District was 5:00 p.m., February 13, 2026, and the deadline for filing an application to be a write-in candidate for director of the District was 5:00 p.m., February 17, 2026; and

Section 1: The election scheduled to be held on May 2, 2026, is hereby cancelled.

Section 2: Mitchell Becker, the unopposed candidate for election to the Board of Directors, is hereby declared elected to office to serve from May 2, 2026, until the directors election on May 4, 2030, or until his successor has been duly elected or appointed and has qualified.

Section 3: Each of said persons shall enter into the duties of office and shall begin to serve his or her term of office upon executing a sworn statement, upon posting a bond in the amount of \$10,000 as required by Section 49.055 of the Texas Water Code, and upon taking the constitutional oath of office.
