ORDER CALLING ELECTION

HAYS CENTRAL APPRAISAL DISTRICT BOARD OF DIRECTORS

AN ORDER CALLING THE GENERAL ELECTION TO ELECT THREE MEMBERS OF THE BOARD OF DIRECTORS OF THE HAYS CENTRAL APPRAISAL DISTRICT TO BE HELD ON NOVEMBER 3, 2026

WHEREAS the Hays Central Appraisal District ("District") is a political subdivision of the State of Texas governed by a Board of Directors pursuant to the Texas Tax Code; and

WHEREAS Section 6.0301 of the Texas Tax Code provides that in counties with a population of 75,000 or more, three members of the appraisal district board of directors shall be elected by the voters of the county at the general election for state and county officers; and

WHEREAS the next general election for state and county officers will be held on **Tuesday, November 3, 2026**; and

WHEREAS the Texas Election Code requires the governing body of a political subdivision to order an election to be held for offices to be filled by election; and

WHEREAS the Board of Directors of the Hays Central Appraisal District desires to call the election as required by law and authorize the conduct of the election by the Hays County Elections Office;

NOW, THEREFORE, BE IT ORDERED BY THE BOARD OF DIRECTORS OF THE HAYS CENTRAL APPRAISAL DISTRICT THAT:

1. An election is hereby ordered to be held on Tuesday, November 3, 2026, for the purpose of electing three (3) members to the Board of Directors of the Hays Central Appraisal District.
2. The offices to be filled at the election shall be:
 - Director, Hays Central Appraisal District – **At-Large Place 1**
 - Director, Hays Central Appraisal District – **At-Large Place 2**
 - Director, Hays Central Appraisal District – **At-Large Place 3**
3. The election shall be conducted countywide as part of the general election and shall be administered by the Hays County Elections Office, acting as the election authority in accordance with applicable provisions of the Texas Election Code.
4. Early voting, Election Day voting, and any required runoff election shall be conducted by the Hays County Elections Office in compliance with all applicable election laws, regulations, and procedures.

5. The Chief Appraiser of the Hays Central Appraisal District, or the Chief Appraiser's designee, is hereby authorized and directed to take all actions necessary to carry out this Order, including submission of this Order to the Hays County Elections Office and coordination as required for the conduct of the election.
6. This Order shall take effect immediately upon adoption.


