We will furnish all material and labor necessary for the completion of the following work:

Minor Inspection:

- Visual inspection of the generator

- Check air filter
- Check coolant level if applicable
- Check battery
- Inspect and tighten all wiring connections
- Check the generator voltage output

Major Inspection: (minor inspection +:)

- Change the engine oil and filter
- Replace the spark plug(s) on LP
- Replace fuel filters on diesel
- Replace air filter
- Check fuel supply system
- Test and fill coolant as needed

<u>Generator Service Agreement</u> Additional Provisions

It is mutually understood that Jackson Electrical Contractors Inc., hereafter referred to as **Jackson**, is not required to furnish replacement parts and supplies other than those listed on the Agreement, nor to supply labor to replace worn or broken parts or to repair damage to equipment due to causes beyond our control or existing prior to our inspection and service. Additional material and labor required will be furnished by **Jackson** at regular selling prices and prevailing rates, less applicable GSA customer discount.

It is understood that:

- 1. *All* work is to be performed during our regular work hours (8:00 a.m. to 5:00 p.m. Monday through Friday). If for any reason, the *Customer* requests work to be performed beyond regular working hours, the *Customer* agrees to pay the difference between regular and overtime labor at regular billing rates.
- 2. Any alterations, additions, adjustments or repairs made by others, unless authorized by **Jackson** shall terminate **Jackson's** obligations hereunder.
- 3. Certified Service furnished hereunder shall not include the normal function of starting and stopping the equipment described below, which function includes the opening and closing of valves, breakers or regulators normally installed to protect the equipment against damage or for obtaining proper operation.
- 4. Any repairs and supplies other than those listed on the front page of this agreement deemed necessary and recommended by **Jackson** for efficient operation of the systems shall be authorized by the *Customer*. Unless these recommendations are accepted by the *Customer* and authorization given to perform this service, **Jackson** will not be held responsible for the proper operation of these systems.
- 5. *In* the event **Jackson** is required to make emergency calls occasioned by failure of system due to damage caused by floods, lightning, fire, Acts of God, or for any cause beyond **Jackson's** control, the *Customer* shall reimburse **Jackson** for the expense incurred in making the emergency call in accordance with the current established rates for performing such service.
- 6. In consideration of the services performed, Jackson shall not be liable for the operation of the equipment, nor for injuries to persons, or damage to property, except those directly due to the negligent acts of omissions of Jackson employees, and in no event shall Jackson be held liable for consequential damages. Jackson shall not be held liable for any expenses incurred for removing, replacing, or refinishing any part of the building structure necessary for the services performed under this agreement. Jackson shall not be held liable for any loss or damage due to delay in furnishing labor or material caused by unusual delays in procuring supplies or for any other cause beyond its reasonable control.

This agreement shall remain in effect for a one-year term. The customer will be sent a renewal invoice prior to expiration of this agreement
