


AND, WHEREAS, in order to raise the necessary revenue for the foregoing appropriated expenditures, it is necessary that the Board of Commissioners of the Town of Lake Lure to levy a tax rate for the fiscal year.

NOW, THEREFORE BE IT RESOLVED that there shall be levied and collected in accordance with existing laws a tax upon all real estate situated in the Town of Lake Lure and upon all personal property owned by the residents of the Town, a rate of \$1.25 per \$100 valuation of said properties, the said tax being necessary to raise the required revenues for the General Fund appropriated and designated herein.

IT IS FURTHER RESOLVED THAT the Town Clerk and Tax Collector is hereby instructed to allow such discounts and to charge and collect such penalties upon such taxes, if and when paid, as are set forth in Section 805 of the Machinery Act of 1933 and all subsequent laws pertaining thereto.
