





A regular meeting of the Board of Commissioners of the Town of Lake Lure was held on Tuesday, November 20, 1945 at which

the following business was transacted:

Mrs. N. A. Greig placed her resignation before the Board as a Town Commissioner, effective immediately. Upon motion and second the motion was accepted.

Upon motion by C. W. Keeter, which was duly seconded, Mr. N. A. Greig was appointed Commissioner for the Town of Lake Lure to fill the unexpired term of Mrs. N. A. Greig. Upon vote same was unanimously adopted.

The following resolution was introduced and motion made to adopt same, which said motion was unanimously passed by the Board:


RESOLUTION

WHEREAS, the sale and shooting or explosion of fire crackers and other fire works in the community of Lake Lure, and especially the shooting of same within the corporate limits of the Town of Lake Lure and especially along Federal Highway # 74 through said town and near the school building and other public buildings of said town, has become dangerous, and has created a nuisance and a hazard to the public, and also has created a fire hazard; and


WHEREAS, it is deemed for the best interest of the public and necessary for the safety of the inhabitants of said town that the sale and shooting or exploding of said fire works within the Town of Lake Lure be prohibited:

IT IS, THEREFORE, RESOLVED AND ORDAINED by the Town that it shall be unlawful for any person, firm or corporation to sell or offer for sale fire crackers or other fire works within the corporate limit of the Town of Lake Lure, and it shall likewise be a violation of law to explode or shoot the same along any public street or highway within the corporate limits of said town, or within five hundred feet of the School Building, Lake Lure Inn, or Administration Buildings, or any other public building within the corporate limits of the Town of Lake Lure, and any person or corporation violating any of the provisions of this ordinance shall be guilty of a misdemeanor and subject to a fine of Fifty (\$50.00) Dollars or imprisonment for thirty days; and each individual sale in violation of the terms hereof, or the shooting or exploding of firecrackers or other fire works, in violation hereof on more than one day, each day on which this ordinance is violated shall constitute a new and separate offense hereunder.

IT IS FURTHER ORDERED that a copy of this RESOLUTION and ORDINANCE be posted at the door of the Town Office, and that the same shall be in force from and after November 21st, 1945.
