At a regular meeting of the Mayor and Board of Commissioners held in the Town Office on Tuesday, January 20, 1948, the following business was transacted:

Upon motion of Commissioner Keeter and seconded by Mr. W. C. Allison, the Town Board authorized the Clerk to employ Thomas J. Edwards, or any other attorney that the Board might deem proper in accordance with such circumstances that may arise for the best interest of the Town.

Mr. Edwards submitted a schedule of fees which in most cases would prevail in charges for his legal services:

- 1-Trips to Lake Lure-Board Meetings, etc.--\$12.50
- 2-Writing up minutes, resolutions, etc.\$2.50 to\$5.00
- 3-Preparing deeds, conveyances, etc. ----\$5.00
- 4-Land or title examinations - - - - \$10. to \$20.
- 5-Tax foreclosures (Inc. Comm's. fees) -----\$20.
- 6-Trials in Superior or Federal Courts
(Including fee of my associate)-----\$100. to \$500.
- 7-Unusual advice(Involving law exam.) - - -\$5. to \$25.

Upon motion and second, meeting was adjourned.
