

The regular meeting of the Board of Commissioners of the Town of Lake Lure met in the Town Hall February 9, 1960, At 7:P.M.

The minutes of the January meeting were read and approved as read.

No old business.

Commissioner Franks made a motion that was unanimously approved by all Board members, the motion stated that the Town rebuild the Greens on the Lake Lure Golf Course and put the Course in good condition for the Spring and Summer season. Funds for the work to be obtained from the sale of timber and pulpwood on the Golf course property. Any additional funds will be borrowed from the General fund, if needed.

The Board discussed the Rental Boat Fees for the 1960 Season.


The Rental Boats with Motors above ten horse power will be \$8.00 per boat.


The Board discussed a Boat Dealers Fee, It was unanimously agreed that Boat & Motor Dealers be granted the privilege of free demonstrations for their Motors and Boats on Lake Lure. The Clerk was instructed to write Boat & Motor Dealers in the nearby Areas of this decision and inform them that any abuse of this privilege, the dealer would be subject to the regular season boat permit.

It was unanimously agreed by the Board that Guest Fishing Permit permits would not be issued to Motels, Hotels and cottage groups.

Carolina Mountain Power Corp. donated to the Town of Lake Lure \$500.00 for the restocking program on the Lake, and \$200.00 for turning the River to its original bed. The \$700.00 to be deducted from February Lake Receipts.

Current bills were approved to be paid.
No other business the meeting adjourned.
