

The Regular Meeting Of The Board Of Commissioners Met
In The Town Hall, Tuesday Evening May 8, 1962 At 7:30
P.M.

The Mayor called the meeting to order.

The first item of business; the Clerk brought to the attention of the Board the request of Camp Lurecrest Owners, Camp Lurecrest Owners request the Town of Lake Lure to give them a Permanent Easement on the Water System and Pipe Lines which furnishes the Camp with Water; this Water System being on the Golf Course Property, owned by the Town of Lake Lure. No action was taken at this meeting.

The Office lease was discussed, the Board agreed to lease the Office space for another year from J. R. Washburn, Sr., \$300, June 1, 1962, \$300, December 1, 1962, lease terminates May 31, 1963.

It was reported by the clerk that Cleston Burgess would accept the Garbage lease for another 1 year period for \$175.00 per month. Tow pick-ups per week during the summer months and one pick-up during the winter months.

The clerk was instructed to have Mr. Cal Wilson buy a second Toro Lawn Mower, Mower to be used at the Golf Course and for the grass plots around business area.

The Board of Commissioners unanimously agreed to sell seven (7) rebuilt Water Meters to residents in the Cane Creek Area at \$18.75 each, also water meter boxes at \$7.50 each; this equipment to be used on the M. L. Nesbit water system; no part of the Town system. New Meters will be offered at cost to Town.

The Board Unanimously agreed to have a 50x50 concrete slab poured on the beach adjacent to the beach house for dancing. Estimated cost \$700.00

The clerk was instructed to include in the Budget for the 1962-1963 fiscal year, \$10,000 for remodeling the East Beach Building for a Town Office.

The clerk was instructed to have the Cocoa Cola Bottling Company install two Automatic Coke Boxes in the Beach House; Also have two Automatic Pepsi Cola Boxes installed in the Beach House.
