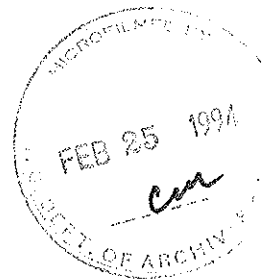


MINUTES OF A REGULAR MEETING  
OF THE BOARD OF COMMISSIONERS OF THE  
TOWN OF LAKE LURE, N.C.  
SEPTEMBER 22, 1981



The regular meeting of the Board of Commissioners was held in the Community Building September 22nd at 7:30 p.m. Members present: Mayor J. Paul Wilson, Commissioners David Bond, Henry Rainey, Woodrow Price and Town Attorney Jervis Arledge.

Minutes of a regular meeting held on August 25th were read. Motion was made by Commissioner Bond, seconded by Commissioner Rainey they be accepted as read and the vote was unanimous.

Mayor Wilson read minutes of a special meeting held on September 17th. The purpose of the meeting was to open bids for the sale of the 1975 Blazer formerly used as a police car. The Board agreed to sell it to the highest bid (1,100.00) submitted by Karl Benoy.

Charles Hicks reported the merchants have agreed to go ahead with the locator sign and Mr. Bland, Officer at Northwestern Bank, will be in charge.


The disrepair of a private road located at Mullis' Camp Ground was again brought before the Board. Mr. Arledge reminded Mr. Whaley they had an agreement a few months ago to have his attorney contact Mr. Arledge to discuss the problem. To date no contact has been made.

Mr. Phillips asked if anything had been decided about his property and Mayor Wilson said the Board had not received a recommendation from the Planning Board. He suggested Mr. Phillips attend the next Meeting of the Planning Board to be held the 1st Tues. of the month.

There was a discussion on reinstating Sunday sales of beer and wine. No action was taken at this time.

To correct the statement made by Robert A. Jones, which gave the impression Fischer Dr. had been paved, Commissioner Bond referred to a report made to the State clearly indicating only the apron was paved.

There being no further business motion was made by Commissioner Bond, seconded by Commissioner Rainey the meeting be adjourned and the vote was unanimous.




MINUTES OF A SPECIAL MEETING
