MINUTES OF THE RECESSED REGULAR MEETING OF MAY 23RD, 1989, HELD AT THE LAKE LURE COMMUNITY CENTER, FRIDAY, MAY 26TH, 1989, AT 9:30 A.M.

The meeting opened with a discussion of how executive session minutes should be kept. Commissioner Moirano suggested that the envelopes that contain the minutes should be sealed.

The Council discussed the budget for 1989-90. Mr. Wade Nelson asked Council to raise the bid of \$36,000 to \$38,400 for garbage collection.

Commissioner William Wildman moved, seconded by Commissioner Moirano to accept Mr. Nelson's bid of \$38,400 for garbage collection in Lake Lure. The vote of approval was unanimous.

Commissioner Alex Karr moved to adopt the ordinance that allows the Town to use auxillary policemen. Commissioner Hugo Moirano seconded the motion and the vote was as follows:

Commissioners Karr, Wildman and Moirano in favor.
Commissioner Queen against.

The ordinance was adopted.


Commissioner William Wildman moved, seconded by Commissioner Hugo Moirano to add a 5th policeman to the staff and to include additional funds in the budget. The additional policeman is being added to enable the police department to have 24 hour coverage of the Town. The vote was approval was unanimous.


Commissioner Queen moved, seconded by Commissioner Karr to pay for the Fairfield Mountains VFD tanker. The vote of approval was unanimous.

Commissioner Moirano moved, seconded by Commissioner Wildman to give \$1500 to the Lake Lure VFD for fireworks. The vote of approval was unanimous.

Commissioner Karr made the motion to recess until June 12th to continue the budget workshop and other applicable business. Commissioner Moirano seconded the motion, and the vote of approval was unanimous.

ORDINANCE

WHEREAS the Board of Commissioners of the Town of Lake Lure deems it advisable to establish an Auxiliary Police Department to be made up of volunteer members; and

WHEREAS North Carolina General Statute §160A-282 provides that by Ordinance a town may establish an Auxiliary Police Department;

NOW, THEREFORE, PURSUANT TO THE AUTHORITY OF G.S. §160A-282, THE BOARD OF COMMISSIONERS OF THE TOWN OF LAKE LURE HEREBY ORDAINS AS FOLLOWS:

1. A Lake Lure Auxiliary Police Department made up entirely of Volunteer members is hereby established.

2. The Board of Commissioners shall have the duty of approval volunteers to serve as auxiliary personnel, together with the duty discharging such volunteer members.

3. Auxiliary law-enforcement personnel shall perform no duties on behalf of the town unless under orders or instructions of the Chief of Police of the Town of Lake Lure.

4. Neither the Town of Lake Lure nor its Police Department shall be liable to the auxiliary law-enforcement personnel for any additional fringe benefits, wages, other compensations, or insurance coverage, except as follows: while undergoing official training and while performing duties on behalf of the town pursuant to orders or instructions of the Chief of Police of the Town of Lake Lure, auxiliary law-enforcement personnel shall be entitled to benefits under the North Carolina Workers' Compensation Act.

5. Neither the Town of Lake Lure nor its Police Department shall be liable to any third parties for any actions, intentional or otherwise, malicious or not, including negligence and/or gross negligence, unless said auxiliary law-enforcement personnel was engaged in the performance of duties on behalf of the town pursuant to orders or instructions of the Chief of Police of the Town of Lake Lure.

6. Neither the Town of Lake Lure, the Town Manager and/or the board of Commissioners, shall be held responsible for the discipline, good order, and proper conduct of the auxiliary law-enforcement Police department.

7. Every person appointed as a volunteer auxiliary law-enforcement department member shall:

- (A) Be a citizen of the United States;
- (B) Be at least 20 years of age;
- (C) Be of good moral character;
- (D) Not have been convicted of a felony or an offense involving moral turpitude;
- (E) Have a high school diploma or its equivalent;
- (F) Be interviewed and approved by the Council.
- (G) Must complete the Basic Law Enforcement Training, be certified as a law enforcement officer, and meet any additional requirements of law.
