MINUTES OF THE THURSDAY, FEBRUARY 3, 1994 RECESSED COUNCIL MEETING HELD AT THE LAKE LURE TOWN HALL AT 9:30 A.M.

Mayor Lehner called the meeting to order at approximately 9:30 a.m.

Council discussed a revision to the boat permit fees which were unanimously approved at the January 11, 1994 regular Council workshop.

The fees approved January 11, 1994 allowed persons to purchase daily boat permits, motorized or non-motorized, on a seasonal basis. Memorial Day through Labor Day was classified as peak season and the rates were established at \$50 per day. All other days were considered off-season and the permits were established to be sold at \$25 per day.

Commissioner Bush moved, seconded by Commissioner Schichtel, to approve the following revision: Daily permits for powered boats and non-powered boats will be sold on a seasonal basis. Memorial Day through Labor Day will be classified as peak season and the rates will be \$50 per day for motorized boats and \$25 per day for non-motorized boats. All other days will be classified as off-season and the rates will be \$25 per day for motorized boats and \$12.50 per day for non-motorized boats. The vote of approval was unanimous.

Council reviewed and discussed the pay and classification and recommended Personnel policy which was prepared and submitted by Robert H. Crowder, Membership Services Consultant, for the North Carolina League of Municipalities.


Council unanimously agreed that the Town Manager will rewrite Section 11, Merit Pay Raises, and will continue Section 12, Merit Bonus Plan into Section 11. When the revision is completed, the Town Manager will present to Council for review.


Council discussed the implementation schedule of the classification and pay plan. Commissioner Bush moved, seconded by Commissioner Schichtel, to approve the classification and pay plan with the appropriate schedules, as submitted by the North Carolina League of Municipalities, with an implementation date effective January 1, 1994. The vote of approval was unanimous.

Mayor Lehner announced that the next meeting, which is a regular workshop meeting, will be held Tuesday, February 8, 1994, 9:30 a.m. at the Town Hall. It was the consensus of Council that the Town Clerk shall notify the news media and all persons who request notice of meetings that the meeting will be held at the Town Hall and not at the Community Center as earlier announced.

With no further items of discussion, Commissioner Bush moved, seconded by Commissioner Donovan, to adjourn. The vote of approval was unanimous.
