2. **Speaker:** Jorge Cisneros, Chief of Police, Anaheim Police Department. Chief Cisneros will say a few words as the new Chief of Police for the Anaheim Police Department, followed by an OCHTTF case walkthrough of *People v. Jefferson*. In June 2015, Dameron Jefferson, 38, was accused of dropping off two young adult females to work the track in an area of Anaheim. Task Force Investigators approached the victims and were led to the defendant while investigating the case. In July 2016, the OCHTTF responded to a missing 15-year-old juvenile from Fresno who may have been trafficked in Orange County. After conducting surveillance at a nearby motel, investigators observed the victim walking into a vehicle with Jefferson (who was out of custody at the time after posting \$50,000 bail) and driven to another motel where the undercover “date” with a Task Force Investigator had been arranged. On July 25, 2018, Jefferson was found guilty by jury and faced a max sentence of 16 years and 8 months in state prison. At his sentencing on August 22, 2018, he was given 12 years.
