The following information is provided to assist you with procedures and requirements for submitting permit request. If you have any questions after reviewing this information, please contact our Customer Service Representatives at 281-298-5522.

The City of Shenandoah has adopted the 2012 Edition of the International Residential Building Code, 2012 International Codes, the 2014 National Electrical Code 2015 IECC. Local ordinances may be viewed at www.shenandoah.tx.us.

Commercial general contractors shall provide general liability insurance in the amount of 1,000,000.00 per occurrence along with workers' compensation coverage; the City of Shenandoah is required to be a Certificate Holder. Commercial subcontractors shall provide general liability insurance in the amount of 1,000,000.00 per occurrences unless Texas state law requires a lesser amount in which case the City will accept the lesser amount; the City of Shenandoah is required to be a Certificate Holder.

Residential general contractors shall provide general liability insurance in the amount of 1,000,000.00 per occurrence; the City of Shenandoah is required to be a Certificate Holder. Residential subcontractors shall provide general liability insurance in the amount of 1,000,000.00 per occurrences unless Texas state law requires a lesser amount in which case the City will accept the lesser amount; the City of Shenandoah is required to be a Certificate Holder.

The City of Shenandoah will no longer accept payment via credit card for fees and fines accessed to building projects. The City of Shenandoah's current fee schedule, is posted for review on the City of Shenandoah website, www.shenandoah.tx.us. The City of Shenandoah strictly adheres to the collection of current fees and fines.

General Information

- Projects must not be started until the permit has been paid for and posted on the job site.
- Electrical and Plumbing permits will be issued separately.

Documents for Plan Review

All plans shall be submitted in a digital PDF format. Plans may be emailed to plans@shenandoah.tx.us, please note that the plans will not be reviewed until application and all payments are made.

- Provide a completed application along a scaled site drawing or survey of the property and the location for the generator equipment to be placed.

- Provide a copy of the manufacture installation instructions for the generator, pad, gas pressure, pipe size, BTU load requirements, and etc.
- Show the location for the existing gas meter and electrical meter for the house. Typically, gas services to the generator is straight off the gas meter, if this not the case please provide information how gas will be routed to the generator. If you install PE pipe for gas underground code requires anodeless risers and a gas test will be required using a fifteen PSI diaphragm gauge with ten PSI test.
- Provide one line for the existing electrical services size, automatic transfer switch size and rating that will be installed.

Inspections

- Generator: Final when the job is complete and the generator is functional.
- Plumbing: Before anything is covered and with a valid test on it.
- Electrical: Before anything is covered and when all connections are made.

It is the responsibility of the owner/contractor to comply with all adopted codes by the City of Shenandoah. Additional information may be required to assure code compliance. Any over site on the part of the city during plan review or inspection does not relieve the owner/contractor from compliance to all codes. Plans must be on site for each inspection.
