The signature on this application shall be an acknowledgement of the Developer/Owner's acceptance of all terms of the agreement.**
- **Before a Street Obstruction or Use permit is issued, a Certificate of Insurance shall be submitted and approved by The Village of Skokie as required by agreement for use of the public way. Closures of public ways shall be according to current MUTCD standards.**

 - **For aerial encroachments / UAV use a onetime ROW permit fee of \$550 per project area to be assessed.**

Residential streets and alleys	\$100 for first 7 days	\$200/day
All other streets and commercial alleys	\$200 for first 3 days	\$400/day
Sidewalk*	\$50 for first 7 days	\$100/day
Village Parking Lots	\$2,000/month

1	*- Sidewalk fee is waived if adjacent street closure is permitted for the same day
2	For closing a parking lane fee will be calculated depending on the street classification
