Water Quality

The Skokie Health Department routinely tests Skokie's drinking water, which is purchased from the City of Evanston, for microbial contamination and levels of chlorine, trihalomethanes, copper and lead. Presence of Pharmaceuticals in Water

In May, 2008, the City of Evanston worked with the Environmental Protection Agency (EPA) to analyze drinking water for the presence of 55 different compounds (including many pharmaceuticals). Samples were collected from tap water and from untreated Lake Michigan water. The results of these tests were reported in concentrations of parts-per-billion (ppb). As a reference, a part-per-billion is equal to one pinch of salt in 10 tons of potato chips or one cent in ten million dollars. Pharmaceutical levels in drinking water are not regulated.

Trace amounts of two substances were detected in the finished tap water: Continine, a derivative of nicotine, at a concentration of 0.003 ppb; and Gemfibrozil, a medication used to treat high cholesterol, at a concentration of 0.0010 ppb. To put the levels of the compounds detected into perspective, Gemfibrozil has a recommended dosage of 600 mg twice per day. Based on the level detected in Evanston's finished tap water, a person would have to drink 64 ounces of water per day for 16,000 years to achieve a single dosage.

Help Prevent Groundwater Contamination

In order to limit groundwater contamination with pharmaceuticals, the Village participates in the Solid Waste Agency of Northern Cook County's expired and unused medication disposal program. Residents can bring medications to the Skokie Health Department from 8:30 a.m.-5 p.m. Monday through Friday for appropriate disposal. The Skokie Health Department accepts approximately 3,000 bottles of expired medications each year as part of this program.
