## Second Annual Downtown Skokie Backlot Bash

## Real Estate Signs

The Village of Skokie has regulations regarding real estate sign postings to maintain consistent aesthetics in the community. These signs include rental and 'for sale' signs.

No more than one real estate sign per street frontage may be posted on any private property. Two signs are allowed for a corner lot. Additionally, no real estate sign can exceed four square feet in size.

Open house signs may be temporarily erected on or above a residential real estate sign on the subject private property. Open House directional signs are allowed subject to the following conditions:

- Only one directional sign is permitted.
- The sign must indicate the responsible agency or individual(s).
- A directional sign may be placed off the premise on private property or the public parkway, for example, a directional sign may be placed on the grass off private property between the curb and public sidewalk and not exceeding a 30 inch maximum height from grade.
- A directional sign may not be placed in the median.
- A directional sign may only be in place Sundays from 12 to 5 p.m. and Tuesdays from 9 a.m. to 1 p.m.

## From the Police Department International Citizens' Police Academy

The Skokie Police Department is proud to offer the fall 2008 International Citizens' Police Academy beginning Tuesday, September 2, 2008.

Classes are held from 7 to 10 p.m. every Tuesday for 12 weeks at the Skokie Police Department located on the corner of Main Street at Laramie Avenue. This session marks the 26th session in which the Citizens' Police Academy has been in place.



The Academy provides insight into law enforcement techniques and is geared to assist immigrant citizens in understanding police practices and programs. Curricula includes: canine unit, criminal law, crime prevention, juvenile law, evidence, traffic stops, 9-1-1 telecommunication, use of force, investigations, gangs and drugs and scams.

There is no charge to attend the International Citizens' Police Academy and materials are provided by the Skokie Police Department. To be eligible to participate in the Academy, individuals must be at least 18 years of age, live or work in the Village of Skokie and pass a criminal background check. Registration is limited to 30 participants so register early. The International Citizens' Police Academy is funded through a grant from The Chicago Community Trust Immigrant Integration Initiative.

## A Message from Mayor Van Dusen

As everyone is aware last winter was one of the longest and snowiest that we've experienced in several years. Because of these weather conditions and the extended plowing and salting, the Village's roadways took a beating.

Due to the need to address the condition of the Village's roads, the Board of Trustees and I increased the road repair budget this year by 40%. Historically we budget approximately \$1.25 million each year for road work. For fiscal year 2008-2009 we've increased the budget by \$600,000 for the High Priority Street Patching Program '08. This increase is being used to patch and repair the Village-owned roads by contracting with a company utilizing state-of-the-art "hot patching" equipment. We're also utilizing funds for an expanded street resurfacing program.

Please know that these programs will only address Village-owned roads. Many of the major streets in Skokie, such as Oakton Street, Crawford Avenue, Dempster Street, McCormick Boulevard, Gross Point Road and Skokie Boulevard, are under the jurisdiction of the State of Illinois or Cook County. Only these units of government have the authority to repair them. The Village has been urging the Illinois Department of Transportation and the County to repair them.

The Village is grateful for the patience of our residents as we go about repairing the roadways. Thank you. ∞

## Village Vehicle Stickers

All vehicles registered with the State of Illinois to a Village of Skokie address must display a valid Village vehicle sticker. Even if the vehicle is not physically in Skokie it must display a Village sticker. The address appearing in the Illinois Secretary of State's records for the vehicle is the criterion. Households with vehicles that are currently registered with the Village began receiving renewal notices in June.

Passenger vehicle stickers are currently on sale at Village Hall. The Collections Division is open from 8:30 a.m. to 5 p.m., Monday through Friday, and from 8:30 a.m. to 12 p.m. on Saturdays from May through October.

Vehicle stickers must be displayed on automobile windshields by August 31. Passenger vehicle stickers purchased through August 31 of each year cost \$20. After that date, the cost increases to \$30 per sticker.

## Skokie Receives Chicago Community Trust Immigrant Integration Grant Renewal of \$50,000

In 2007 the Village of Skokie received a \$50,000 grant from The Chicago Community Trust as part of the Trust's \$1.5 million immigrant integration initiative. In spring 2008, the Village applied to renew the grant for the 2008-2009 granting year and was recently informed that it will receive an additional grant in the amount of \$50,000.

Skokie's grant proposal was one of less than a dozen funded out of a total of over 50 applicants. The grant proposal was initially developed with advice from an Immigrant Integration Grant Advisory Committee comprised of Festival of Cultures executive committee members and others from Skokie's international community.

The Village Manager's Office, Human Services Division and Police Department are collaborating on grant-funded initiatives designed to provide services or training to immigrant residents. Specific grant-funded initiatives planned for the 2008-2009 granting year include:

## Skokie Fire Department Retains Prestigious ISO One Designation

The Skokie Fire Department has once again achieved the prestigious Class 1 rating from the Insurance Services Office, Inc. (ISO). Skokie first received this designation of exemplary public protection in 1995 that includes rigorous evaluation of staffing, equipment, training, dispatch staffing and equipment and the water supply and system. This rating renewal is effective September 1, 2008 and based on ISO current practice, it will be evaluated every two years through a community outreach survey.

The Skokie Fire Department is one of only 57 fire departments in the country with an ISO Class

1 rating. The Skokie Fire Department also is accredited by the Commission on Fire Accreditation International, and is one of only seven agencies in the nation that have this accreditation and an ISO Class 1 designation.

ISO is the leading supplier of statistical, underwriting and actuarial information for the property/casualty insurance industry. Most insurers use ISO and therefore their Public Protection Classification (PPC) for underwriting and calculating premiums for residential, commercial, and industrial property insurance rates. ISO has evaluated and classified over 44,000

fire protection areas across the United States. Fire Departments can receive any rating from 1, being the best, through 10, being the lowest. Ninety percent (90%) of the standards must be met to achieve a Class 1 rating.

To determine a community's rating, ISO conducts a field survey. Highly qualified ISO staff visit the community and observe and evaluate features of the fire protection systems, including water supply/distribution, fire alarm and communications systems and fire department operations. The ISO staff conducted the Skokie Fire Department evaluation in August 2007. ∞

## Traffic Laws for Vehicles, Pedestrians and Bicycles

### Vehicles

While they may be an easy way to decorate your car, license plate covers are illegal in Illinois. License plate covers of any kind - tinted, colored, painted, marked, illuminated, and even clear - are not allowed within Illinois. Law enforcement can more easily identify the registration plate on the vehicle without the obstruction of a cover. Many of the plastic covers including the clear ones become scratched and discolored over time obstructing the view. Even the glare from the sun during the day and headlights at night distort the view of the plate and make it harder to read.

This detailed law has only been around since 2006. Unfortunately, many retailers either are not knowledgeable of the ever-changing laws within the state or they choose to ignore them. It is up to the consumer and vehicle owner to stay aware of the legislation.

With many people trying to reduce the amount of miles they drive, walking around town is becoming more popular. Walking around an urban environment is no easy task. Both motor vehicle drivers operating on the street and the pedestrians walking adjacent to them have to be vigilant at all times in order to maintain safety.

### Pedestrians

Pedestrians are only allowed to cross a street at an intersection or a designated, marked crosswalk. Rules at signalized intersections are the same for pedestrians as they are for vehicles. This means that pedestrians must obey all traffic signals - green, yellow or red - unless otherwise directed by a pedestrian control signal, just as a car would. Pedestrians facing a green light, not a green arrow, may cross the road within any marked or unmarked crosswalk. Pedestrians facing a yellow light are advised there is insufficient time to cross and may not enter the roadway. Red lights are simple: do not cross. Traffic on the adjacent roadway must yield the right of way to those lawfully in the crosswalk whether the intersection is signalized or not. Remember those pedestrians who suddenly leave the curb and walk into the path of a moving vehicle are unprotected by the law. This is akin to a car suddenly ignoring the red light and moving into traffic.

### Bicycles

Riding a bicycle is a great way to exercise and save gas money. As you ride your bike on the road, please remember that not only are bicycles granted all of the rights afforded to motor vehicles but they also are subject to all of

the same rules as motor vehicle drivers. Bicycles are only allowed to carry the same number of people as they have fixed seats. Unless preparing to turn left or trying to avoid a collision, all bicycles must be on the right side of the road.

Riding a bike with a friend is a great way to spend a day, but don't forget that bicycles cannot ride more than two across and can't impede the normal movement of traffic. If you plan on riding your bike to run errands, you might want to have a basket or wear a backpack. Bike riders must not carry any item that prevents the use of both hands to operate the bike. If you are riding your bike on the sidewalk, you must yield to all pedestrians. At a crosswalk, bike riders have the same rights and responsibilities as pedestrians. While bicycling is fun and economical, it also can be unpredictable. While helmets are required for those bike riders under 17, it just makes sense for all bike riders.

Whether you are out walking around town or riding your bike, remember that you are subject to almost the same rules as those who drive a car. If you would not ignore a red light when you are driving, why would you do so when you are on a bike? Please make sure to enjoy these wonderful activities safely this summer and always. ∞

## Recent Village Board Action

The Village Board approved the Fiscal Year 2009 (FY09) budget with an additional \$600,000 allocated for street resurfacing and patching. In summary, the General Fund for FY09 equates to \$48,561,640. All funds, including the following: Water, Pension, Economic Development, Motor Fuel Tax, Performing Arts Center, Convention and Visitors Bureau, and Capital Improvement Program, total \$103,987,708.

The Village Board approved a three-year agreement with the Chicago's North Shore Convention & Visitors Bureau. Skokie, Evanston, Northbrook and Glenview are current bureau members. Skokie has been a Bureau member since 2002.

The Village Board approved a radio advertising campaign on WBBM-AM for the 2008-2009 year. The advertising campaign will consist of about 146 30-second commercials over a 26-week period and will focus on economic development.

The Village Board approved the establishment of an AM radio station to use for emergency communications, particularly during power outages. During non-emergency times the station will run public service announcements. The Federal Communications Commission has issued Skokie the 1660 AM channel and the station should be functioning by fall 2008.

The Village Board approved several bids for new computer and 9-1-1 equipment for the Police Department. The replacements are funded through monies awarded to the Village as a result of the PrimeCo litigation.

The Village Board approved a water rate increase of 9.32%. The monthly increase to the average residential water customer is anticipated to be \$2.43. The rate is based on the 2% annual rate increase for water the Village purchases from the City of Evanston, the expenses associated with investing in the aging water system infrastructure and the adjustment in the expected water consumption. Even with this increase, Skokie will continue to have the second lowest water rate among recently surveyed municipalities.

## Board and Commission Members Needed

The Village's many fine programs and services rely on community volunteers. More than 250 of your neighbors volunteer their time and expertise to ensure that Skokie is a great place to call home.

Commissioners are appointed by the Mayor and approved by the Village Board. Skokie Boards and Commissions include: Advisory Commission on Disabilities, Advisory Commission on Human Services, Beautification and Improvement Commission, Board of Fire and Police Commissioners, Board of Health, Board of Local Improvement, Cable Television Advisory Commission, Consumer Affairs Commission, Fine Arts Commission, Human Relations Commission, Plan Commission, Traffic Safety Commission, Zoning Board of Appeals and Zoning Commission.

## Skokie's Going 'Green'

*Skokie's Going 'Green' article communicates the Village's environmentally friendly practices and initiatives and features 'green' tips for residents and business owners.*

**Did you know that in 2006, over 69 million gallons of latex paint was dumped into our country's landfills?**

Improper disposal of latex paint can be very harmful to the environment. To assist in keeping latex paint out of landfills, Ace Hardware, 5035 Oakton Street accepts latex paint as part of a latex paint recycling program.

For a small fee, the paint will be properly recycled into new, useable latex paint. Any latex

paint that cannot be processed for reuse will be turned into a filler product for the manufacturing of concrete.

The recycling fee for latex paint containers are:

- \$1.50 per quart container
- \$2.50 per gallon container
- \$8.00 per five-gallon bucket

## Yard Waste Collection

*Village crews collect yard waste once per week on Wednesdays through October 15.*

The Village of Skokie transports all refuse and yard waste to the Solid Waste Agency of Northern Cook County's (SWANCC) Transfer Station in Glenview. If a load of refuse includes improperly packaged yard waste and/or regulated material, SWANCC may decline the entire load. Residents cannot mix yard waste with their household refuse.

### Yard Waste Guidelines

- **Grass, Plant Material and Small Brush:** Leaves, lawn and shrub clippings must be containerized in a paper yard waste bag and shall not exceed 50 pounds.
- **Large Brush:** Bundles must be tied with string, twine or rope, and bundled small enough to be lifted by a single waste collector. Each branch cannot exceed three inches in diameter, and cannot extend longer than five feet in length and shall not exceed 50 pounds.

Place bundles in the alley or at the front curb for collection (in the same area as refuse collection). The use of wire, nylon, or plastic ties is prohibited.

- Residents must make arrangements with a private landscaper or tree service for collection of brush, branches

or logs exceeding three inches in diameter and five feet in length.

Residents requesting yard waste disposal after October 15 should call Public Works in advance at 847 933-8427 to schedule a special pickup.

## Parkway Tree Planting

Residents with an open planting space on their parkway are invited to contribute to the Village's urban forest by planting a new tree in their parkway. The Village will pay 50% of both the cost and planting of the new tree.

Homeowners may select a tree from a list of suitable parkway trees. Please contact the Village Forester for the most current listing of trees. Resident costs range from \$120 to \$175 depending on the species.

This program is offered for both the fall and spring planting seasons.

The Forestry Division also plants trees to replace those removed through its reforestation/replacement program. Trees are removed from parkways only if they are diseased, dead or deemed a public safety hazard.

The resident is responsible for contacting the teen and for making financial and scheduling arrangements.

## School Immunizations

As the school year approaches it is time to make sure your child's immunizations are up to date. The Skokie Health Department would like to offer some facts about vaccines.

Unfortunately, misinformation about vaccines may lead some parents to decide not to immunize their child, and this may put the child and others at a greater risk for illness. It is impossible to get a disease from any vaccine made with dead bacteria or viruses, or just part of the bacteria or virus. Only those immunizations made from weakened live viruses - like the chicken pox (Varicella) or measles, mumps, and rubella (MMR) vaccine - could lead to a mild form of the disease. Fortunately these instances are rare and are almost always much less severe than when a person is infected with the disease-causing virus itself. The risk of disease from vaccination is extremely low.

Some parents think it is acceptable to skip vaccinations because all other children are vaccinated. The fact remains that each child who is not immunized gives highly contagious diseases another chance to spread. An occurrence of this actually happened between 1989 and 1991 when an epidemic of measles broke out in the United States. There is no reliable way of knowing if everyone your child comes into contact with has been vaccinated, particularly now that so many people travel to and from other countries.

Some people fear their child will have a reaction to an immunization shot. The most common reactions to vaccines are minor, including redness, fever, and rash and swelling where the shot was given. Although in rare cases immunizations can trigger seizures or severe allergic reactions, the risk of these is much lower than that of a non-immunized child catching the disease. Every year millions of children are safely vaccinated and very few experience any significant side effects.

Another misconception is vaccinations aren't needed because the diseases don't exist here.

## West Nile Virus

The Skokie Health Department staff works diligently each summer to monitor mosquito activity in the Village and to eliminate potential mosquito breeding sites to lower the risk of West Nile Virus (WNV). At the time of publication, no positive mosquito pools have been detected and no human cases of WNV have been reported in Skokie. Based on WNV history, this is likely to change by August. We cannot predict the future but we all can help to minimize the risk of mosquito-borne disease in our community.

Prevention is the key to preventing WNV. This must be a collaborative effort between governmental agencies such as the Skokie Health Department and the North Shore Mosquito Abatement District and you as an individual and a property

Diseases that are rare or non-existent in the United States still flourish in other parts of the world. Doctors continue to vaccinate against diseases because it is easy to come into contact with illnesses when traveling. This includes anyone who may not be properly immunized coming into the United States, as well as Americans traveling overseas.

There also are some people who think that once a child has had their initial series of vaccinations no more are needed.

There are a few vaccines, like the one for measles or the series for hepatitis B, that may provide

lifetime immunity. Others, like tetanus, last for many years but require periodic shots (boosters) for continued protection against the disease. It is important to keep a record of your child's shots so you will know when they are due for a booster.

owner. Measures you can take to reduce your risk of being bitten by a mosquito include: staying indoors at dawn, dusk or early evening; wearing long-sleeved shirts and long pants whenever you are outdoors; if entering a heavily wooded area, consider spraying your clothing with repellents; wearing protective clothing including hiking boots and gloves and applying insect repellent sparingly to exposed skin. The most effective repellents usually contain DEET. Property owners can eliminate mosquito breeding areas in the following manner:

- Remove standing water where mosquitoes can breed.
- Clean and maintain any catch basins that may be on your property. The North Shore Mosquito Abatement District will treat your catch basin for

mosquito larvae if you call them at 847/446-9434.

- Change the water in birdbaths and plant pots at least once a week.
- Empty plastic pools at the end of each day and store indoors.
- Keep grass and shrubbery cut short. Adult mosquitoes accumulate in shady cool areas.
- Keep gutters clean and free-flowing. Eliminate dips and low areas that collect water.
- Don't let water stand on flat roofs.
