

## Alternate Side Parking Program: Are You Ready for Snow?

Alternate-side parking during heavy snow allows Skokie's Public Works Department to efficiently plow Village streets. The mandatory program is designed to provide the ability to plow the streets from curb-to-curb within a two-day period. Residents should call 847/675-SNOW (7669) or tune to 1660 AM, Skokie's new advisory radio station, to confirm that the program is in effect and for program updates. ### Frequently Asked Questions

#### • On what side of the street do I park?

On odd-numbered dates, residents park vehicles on the odd-numbered side of the street. On even-numbered dates, residents park vehicles on the even-numbered side of the street. Odd and even dates are determined by the date on the calendar. Odd and even sides of the streets are determined by house addresses.

#### • When is alternate-side parking in effect?

The alternate-side parking plan is in effect between the hours of 8 a.m. and 6 p.m. after any snowfall of two inches or more. An alert siren sounds to signal the start of alternate-side parking at 7 a.m. each day the plan is in effect. Cable television subscribers are alerted through the Village emergency over-ride system at 6 a.m., 7 a.m., 8 a.m. and 6 p.m. Additional information can be found on the SkokieVision cable station, 1660 AM (see article to the right for details) or by contacting 847/675-SNOW(7669) for a recorded status report.

#### • How many days does alternate-side parking last?

The program generally is in effect for at least two days. To find out if it is extended, call 847/675-SNOW (7669).

#### • What should I do with my vehicle(s) while on vacation or while I am at work?

Residents who do not have off-street parking facilities must make arrangements to have vehicles moved when the program is in effect.

#### • May I park on either side of the street once the street is plowed?

No, even after the street is plowed, your vehicle must remain parked on the proper side of the street until 6 p.m. This allows Public Works crews to plow a second time if necessary. At 6 p.m., an alert warning siren will sound notifying residents that cars may be moved to either side of the street.

#### • To what location is a vehicle towed if in violation?

If your vehicle has been towed due to a violation of the Village's snow ordinance, contact the Police Department at 847/982-5900.

### Village of Skokie Launches Advisory AM Radio Station

To improve communication and enhance the safety of those living, working and visiting in Skokie, the Village of Skokie has installed an advisory AM radio station. The frequency of the station is 1660 on the AM dial. Hundreds of communities, universities and government agencies across the country now operate advisory AM radio stations to tell citizens what to do during an emergency or critical situation. Advisory radio stations give listeners direct, repeated, up-to-the-minute reports, alerts and relevant instructions.

The primary use of 1660 AM Skokie is to inform the public of emergency conditions in the area and how to respond to them. An emergency could consist of severe weather to hazardous material spills, alternate-side parking when there are two or more inches of snow on the ground or any other condition that could affect the well-being of the public in the Skokie area.

This non-commercial radio station is monitored by the Village, and in non-emergency situations, the station will broadcast emergency preparedness and Village of Skokie information 24 hours a day, seven days a week. New AM radios in cars and other radios will be able to receive frequency.

**• Are there streets that are exempt from snow parking provisions?**

**• Are state and county roadways exempt from snow parking provisions?**

Yes, the following roads are exempt from the program: Crawford Ave. (Jarvis Ave. to Old Orchard Rd.), Church St. (Gross Point Rd. to McCormick Blvd.), Church St.

(Linder Ave. to Gross Point Rd.), Gross Point Rd. (Church St. to Old Orchard Rd.), Golf Rd. (McCormick Blvd. to Harms Rd.), Gross Point Rd. (Lincoln Ave. to Howard St.), Lincoln Ave. (Linder Ave. to Jarvis Ave.), McCormick Blvd. (Touhy Ave. to Golf Rd.), Niles Center Rd. (Pratt Ave. to Brown St.), Oakton St. (Skokie Blvd. to McCormick Blvd.), Old Orchard Rd. (Harms Rd. to Crawford Ave.), Skokie Blvd. (Jarvis Ave. to Old Orchard Rd.) and Touhy Ave. (east to west limits).

**Refuse Carts and Fire Hydrants**

Refuse collectors have a difficult time emptying refuse and recycling carts that are buried by drifts or piles of snow. Residents are responsible for ensuring that refuse containers are accessible. Please clear a path for the crews so that your recycling and refuse can be picked up as scheduled.

In addition, snow plowing operations may cover your fire hydrant. Please assign someone in your household the responsibility of keeping fire hydrants on or near your property clear of snow for easy access. Snow piled on top of fire hydrants slows fire response time. In the event of a fire emergency every second counts!

## Public Art Advisory Committee Installs First Sculpture, Second Scheduled for Spring 2009

### *The Glowing of Such Fire*

The first sculpture chosen and purchased by the Village of Skokie Public Art Advisory Committee (PAAC) is *The Glowing of Such Fire* by Richard Taylor. The sculpture was installed on October 21, 2008 in the Village Green, located between Skokie Village Hall (5127 Oakton Street) and the Skokie Public Library (5215 Oakton Street).

### *Gourd Man*

Artist Shencheng Xu was commissioned to install a second public art sculpture at the November 3, 2008 Village Board meeting. *Gourd Man* will be installed in the Village Green in early spring 2009.

### *Purpose of the Committee*

The purpose of the PAAC is to integrate a wide range of public art into the community that reflects the diversity of the Village, various artistic disciplines and points of view, as well as to:

- Promote vitality and economic development throughout the community;
- Develop a collection of public art which has strong aesthetic quality and a wide range of artistic styles and disciplines;
- Encourage collaboration among artists, architects, engineers and property owners for the public display of art so that buildings, store facades, parks and open spaces are in aesthetic harmony with public art;
- Provide opportunities for professional artists to sell or lease their art to the Village of Skokie; and
- Disperse public art throughout the community with an initial focus in Downtown Skokie.

### *Call for Professional Artists*

The PAAC continues to look for art in a wide variety of media and styles, but all

sculptures must be durable and suitable for outdoor placement. Only professional sculptors and artists who have worked on large scale format should apply.

## 2009-2010 Community Development Block Grant (CDBG) Program

Each year under Title I of the Housing and Community Development Act, the U.S. Department of Housing and Urban Development (HUD) provides block grants to qualified local communities.

Skokie expects about \$480,000 in funding for the fiscal year beginning May 1, 2009. These funds are used for physical improvement projects, housing programs, limited social services and other activities that are consistent with local planning goals and Community Development Block Grant (CDBG) regulations.

Eligible projects must meet national objectives by principally benefiting people in the community with low to moderate income or aiding in the prevention and elimination of blighted conditions. All projects are approved by HUD before funds are released.

The Village has scheduled three public hearings to solicit public input on the 2009-2010 CDBG Program. Information gathered at the hearings assists in formulating the Village's funding request to HUD. At the December 15, 2008 Village Board meeting, the Board will review the current year's program progress and discuss 2009-2010 community development needs and objectives.

Project suggestions, comments and program recommendations that are solicited from Village staff, citizens and representatives of various social agencies will be presented at the January 5, 2009 Village Board meeting. The Board will select the projects to be funded at the February 2, 2009 hearing. Village Board meetings begin at 8 p.m. and Community Development Block Grant hearings are held at the close of regular Village business.

## 2009 Refuse and Recycling Schedule

### Refuse Collection

A 95-gallon refuse container is provided to each single-family household for storage of up to 200 pounds of household refuse, with the exception of hazardous materials and construction debris. These items require special disposal. For more information on hazardous waste and construction debris disposal, please visit [www.skokie.org](http://www.skokie.org).

- *If you live north of Greenleaf Street or on the north side of Greenleaf Street, refuse is collected on Monday and Thursday.*
- *If you live south of Greenleaf Street or on the south side of Greenleaf Street, refuse is collected on Tuesday and Friday.*

Collections are made in the alley where alleys are present and at the curb in front of the house where alleys do not exist. In order to ensure collection, refuse containers must be set out by 7 a.m. on the scheduled collection day. Refuse containers should not be set out prior to 6 p.m. on the night before collection and containers cannot remain at the curb past 6 p.m. on the night of collection. Residents with refuse collection in the alley should make sure that their backyard landscaping does not impede into the Village right-of-way.

**Friday, December 25 - Christmas Holiday:** Monday and Tuesday collections unchanged, Thursday collection on Wednesday, Friday collection on Thursday.

### Recycling Collection

Residents are provided with 65-gallon carts for recyclable materials. Collection of recyclable materials occurs every week in single-family residential areas. The total weight of the filled cart should not exceed 150 pounds. Please flatten large boxes and place them next to the cart. Please do not mix garbage and landscape waste in the recycling cart.

- **MONDAY:** Residents living east of Kostner Avenue and north of Greenleaf Street have recycling collection every Monday.
- **TUESDAY:** Residents living east of Kostner Avenue and south of Greenleaf Street have recycling collection every Tuesday.
- **THURSDAY:** Residents living west of Kostner Avenue and north of Greenleaf Street have recycling collection every Thursday.
- **FRIDAY:** Residents living west of Kostner Avenue and south of Greenleaf Street have recycling collection every Friday.

In curbside collection areas, set out recycling containers by 7 a.m. on the day of pickup, but not before 6 p.m. on the night before collection.

## Emergency Preparedness in Skokie

### Tip of the Month: Communicating During an Emergency

During emergencies the importance of communications systems becomes clear. The Village has an extensive network of communication avenues to employ during an emergency. Depending on the emergency some of the communication systems may temporarily be unavailable. To address this concern the Village has developed multiple communication avenues. The following tools are available for emergency communications:

- **1660 AM Skokie:** The Village of Skokie recently launched an advisory radio station which will assist in communicating up-to-date information to the community during an emergency. During times of non-emergency, the radio station will play emergency preparedness information 24 hours a day, seven days a week. For more information on 1660 AM Skokie, please turn to the front page.
- **www.skokie.org:** During a municipal emergency, residents are encouraged to visit [www.skokie.org](http://www.skokie.org). The site is frequently updated and serves as a valuable reference guide during municipal emergencies. With the recent launch of the redesigned [www.skokie.org](http://www.skokie.org), residents can access an Emergency Preparedness webpage (accessible from the left navigation menu from any page). The Emergency Preparedness webpage is a combination of information provided by the Skokie Fire, Health and Police Departments and provides preparedness information, tips and links to other emergency preparedness websites. - **SkokieNews:** Subscribers to this electronic newsletter will receive updated information during an emergency. Visit [www.skokie.org](http://www.skokie.org) to subscribe.
- **SkokieVision Cable:** The municipal cable station provides both video and text information relating to an emergency and, when necessary, instructions on where to obtain further information.
- **Emergency Override:** During a municipal emergency the Police Department can override programming on Comcast cable channels and place a written crawl on all RCN channels. The override is used to distribute a brief message dur-



ing an emergency. It is typically used to signal the start and conclusion of alternate-side parking during snow emergencies.

- **Telephone Messaging:** The Village's high-speed telephone dialing system is designed to deliver a recorded emergency telephone message to Skokie residences and businesses. The system is flexible enough to target only certain households or it will dial the entire community over a several-day period.
- **Outdoor Warning System:** Warning sirens are strategically placed throughout the community. The warning sirens are used most commonly to signal the start and end of the snow emergency alternate-side parking program but can be used to alert the residents of a tornado or other emergency situation. - **Broadcast and Print Releases:** During an emergency the Village keeps radio, broadcast and print media regularly informed through press releases. The releases are also available at [www.skokie.org](http://www.skokie.org).
- **Threat Condition Updates:** The U.S. Department of Homeland Security provides "up-to-the-minute" changes in threat levels. Their color-coded Threat Level System is used to communicate threat levels so that protective measures can be implemented to reduce the likelihood or impact of an emergency. The Department of Homeland Security also offers information about establishing an emergency plan and information on what to do during an emergency. ## Recent Village Board Action

The Village Board heard a presentation by Management Analyst/Public Information Officer Natalie Marquez regarding the updated Village of Skokie website, [www.skokie.org](http://www.skokie.org). The website was launched in late October, 2008, and incorporates a modern design, more updated navigation and enhanced search functions.

The Village Board heard a presentation by Temporary Zoning Commission Chair Peter Nicholas concerning recommendations on the creation and mapping of three new mixed-use zoning districts and other associated amendments to the Zoning Chapter of the Skokie Village Code as part of the implementation of the 2020 Plan for Sector A: Downtown, adopted by the Village Board on October 1, 2007.

The Village Board adopted a resolution authorizing the execution of an agreement for the purchase and installation of a public art sculpture known as *Gourd Man* at the Village Green. The art purchase is funded from the Village of Skokie's Appearance and Arts Fee. This is the second purchase of public art through the Public Arts Advisory Committee.

The Village Board approved a resolution authorizing an emergency water interconnection agreement between the Village of Skokie and the Village of Lincolnwood. The agreement will allow a new emergency water interconnection with the Village of Skokie's water system at Cicero and Jarvis Avenues. Once this interconnection is established, the existing interconnection at Pratt and Lavergne Avenues will be abandoned. Lincolnwood has agreed to pay all costs and expenses associated with the design, permitting, construction and installation of the emergency interconnect.

## 2008 Village Open House

Nearly 400 people were in attendance at the Sunday, October 26, 2008 Village Open House. Skokie residents viewed Fire, Police and Public Works Department displays as well as information displays provided by Village of Skokie departments, Skokie public schools and community organizations. Attendees also enjoyed donut holes, apple cider and chili prepared by the Skokie Fire Department.

## Have You Prepared Your House for Cold Winter Weather?

### Frozen Pipes

Frozen pipes usually occur for one of three reasons: when cold outside air leaks into the house and freezes the water in pipes, when homeowners lower the thermostats in their houses to 55 degrees or less when they are out of the house or when the pipes in crawl spaces or attics are not properly insulated. If you turn on your faucet and only a trickle of water comes out a pipe may be frozen.

If you choose to thaw the pipe yourself do not use a blowtorch, kerosene or propane heater or any open flame device.

It is advised that you have a licensed plumber assist if you cannot immediately locate the frozen pipe.



### Ice Dams

Ice dams are the result of melting water and ice entering attics via the roof shingles. Dams primarily occur after a cycle of melting-freezing days. Water from ice dams may damage ceilings, walls, floors and household items.

To reduce the chances that an ice dam will form be sure to clean out all gutters and downspouts, replacing or repairing those which are damaged, and do not allow ice or icicles to accumulate in or around gutters.

## Holiday Safety Reminder from the Skokie Health Department

You can help keep your holiday season safe and happy by following some simple safety precautions from the Skokie Health Department.

Choosing the right gift for children is very important. Many accidents result from giving gifts inappropriate for a child's age. Toys are rated for the youngest age at which they can be safely used. Please don't give a child a toy rated for older children.

Proper disposal of packaging and wrapping paper also is important. Keep plastic bags and wrapping away from small children. Gift wrapping should not be burned in the fireplace. People have been severely injured by flash fires that result when highly volatile wrapping materials are thrown on a fire.

Alcohol-related accidents account for the majority of holiday traffic deaths. When going to a party or out with friends, choose a designated driver. When hosting a party, have non-alcoholic beverages available for your guests. Stop serving alcohol at least one hour before the party's end. People who have had too much to drink should be given a ride home or persuaded to use public transportation. Under no circumstances should you allow your guests to drive if they have had too much to drink.

## Where Did All those Holiday Calories Go?

Many people measure the result of their calorie intake by using a scale to weigh themselves. This is not the best way to determine fitness or to make a judgement about your health status.

Lean mass actually weighs more than fat mass. Therefore, a very muscular person's weight might indicate that he is not physically fit when in fact, he is. On the other hand, an inactive, non-muscular person's weight might indicate that he is physically fit when in fact, he isn't.

A better way to measure fitness is by determining your fat-to-lean ratio. The Skokie Health Department offers a quick and easy way to determine this ratio. Body composition analysis uses near infrared light to determine the amount of fat and lean tissue you have. A comprehensive, four-page printout is generated to help you improve your physical fitness.



The Health Department conducts body composition analysis on Monday afternoons, Thursday mornings and on Wednesday evenings. The testing is done by appointment only and costs \$4.
