Leaf Collection Begins and Yard Waste Collection Ends


Regularly scheduled yard waste collection for the 2011 season concludes after the November 9, 2011 collection. On Monday, October 17, 2011, the Village begins its annual leaf collection pro-

gram that continues through early December, weather permitting. Instead of bagging, or for those who do not mulch leaves, residents may rake leaves into the street next to the

curb in front of their home. Residents are reminded not to place their leaves in the street prior to the beginning of the leaf collection season. As weather permits, Village crews make rounds throughout Skokie collecting the leaves on a weekly basis. Please follow these tips to insure collection:

- Rake leaves away from parked cars and do not park on leaf piles.
- Be mindful of fire hydrants and keep them visible.

- Wetting leaves while piled prevents them from blowing away.
- Do not rake leaves onto or in sewer drains.
- Please do not add grass piles, twigs and branches or other garden debris to leaf piles as these items can damage equipment and prevent leaf collection.

Spotlight on the Zoning Board of Appeals

The Zoning Board of Appeals (ZBA) is charged with hearing requests that do not meet certain Zoning Chapter requirements. The Zoning Board of Appeals reviews exception permits and variation requests. Exception permits may involve fence height or the location of air conditioning units, swimming pools or barbecues. Variations include the location and size of accessory buildings and structures, lot coverage by buildings or impermeable surfaces, floor area ratios, yard requirements, off-street parking, commercial vehicle parking and substandard lots.

The Corporation Counsel's Office and Community Development Department provide staff advisors to the ZBA. The Zoning Board of Appeals is a final hearing body, with only specific types of appeals requiring Village Board action. There are nine members on the Zoning Board of Appeals, each serving a four-year term. Meetings are usually held on the first and third Wednesday of each month at 7:30 p.m. in the Village Council Chambers.

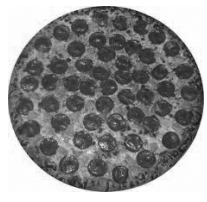
What is your favorite shop or restaurant in Skokie?

Be Aware of Senior Scams

Nothing can be more devastating for a senior than being financially scammed out of money that many have taken a lifetime to accumulate. Help the Skokie Police Department protect seniors by making sure you and your family are aware of some of the most common senior scams.

Many people are aware of the typical scams where criminals try to gain information over the phone or internet, many times by trying to confuse the senior. Other unsavory methods include scaring the senior into thinking that if they do not respond quickly to the requests of the scam artist, then they will lose larger amounts of money.

These scams include:

Ruse Entry (Most Common)

The con begins with an offender offering to provide an inexpensive service since they just completed work in the area. While one offender distracts the senior, the other offender enters the residence and removes items.

Telemarketing Scams

The scam begins with a con artist conducting a harmless survey regarding an unrelated topic only to call back several weeks later with bank or financial information that was previously given out but had been long forgotten by the victim. The con ends with instructing the victim to provide credit card information, bank information or other financial details.

The Bank Examiner

A scam where the victim is led to believe that they are assisting the police or other authorities in apprehending a bank employee who is committing some sort of crime at the bank. The victim is

asked to go to the bank and withdraw a specific amount of money. The victim then turns the money over to one of the con artist as evidence of the crime.

Lotto Hustle

A short con where the victim is approached on the street by a person claiming to have won the lottery. However, they can't cash in the ticket because they are not a citizen. The victim usually purchases the ticket for a percentage of its value. The ticket is forged or altered.

Pigeon Drop (several variations)

A con where the victim and the con artist find a large sum of money. The victim is asked to produce some of their own money for various reasons, depending on what variation of the con game is being used. The con ends with the victim holding some cut up newspaper, a worthless check or an empty bag.

What Can You Do?

These crimes can be prevented by simply being aware of the scams and looking out for seniors in our neighborhood and family. Many seniors often do not report crime for fear of being criticized by family members.

Village Board Action

The Village Answers Your Questions!

Village officials are frequently questioned by residents on numerous topics. For several months the Village has been featuring a question of the week on the Village website, www.skokie.org, answering some of the more popular questions. Below is a sample of these questions. Why are there so many property foreclosures and what is the Village's response to them?

Many Skokie residents have been affected by foreclosures. Since 2007, when the Village started tracking foreclosures, 1,867 properties have gone into the foreclosure process. Most of these properties have been residential. The Village tracks these foreclosures and inspects them to assure that they do not fall below acceptable community standards.

Each month the Property Standards Division performs an exterior inspection of each property. Inspections are made to assure that the properties are still well maintained and secure if not inhabited. The Village works with bank maintenance companies to assure that issues are addressed. The Fire, Police and Public Works Departments also are informed about the properties to perform safety inspections.

The Public Works Department shuts off water to vacant foreclosed properties to assure that water damage does not occur during winter months.

The Human Services Division provides counseling to property owners to help prevent the completion of the foreclosure process when possible. Recently there have been signs that the number of foreclosures is declining and that many of the foreclosed properties are being resold.

If my property assessment is the same as last year, why is my tax bill so different from year to year?

Many factors impact the final property tax bill. First, other than Skokie, the levies of many agencies increase each year. This is particularly true for school districts.

Second, the value of the homeowner's exemption has changed a number of times recently making comparison to prior years extremely difficult.

Finally, as a result of property assessment appeals, your property may change in proportion to the Village as a whole. While any single residential property is a very small portion of the Village, large properties that receive downward assessment spreads the tax burden across all other properties in Skokie.

What is Section 8 housing and is it increasing in Skokie?

Section 8 of the Housing Act of 1937 first authorized the payment of federal money for rental housing assistance to private landlords. Most such payments are administered through the United States Department of Housing and Urban Development (HUD) and are officially termed Housing Choice vouchers. Low-income people who receive such vouchers have the right to relocate and use the voucher anywhere in the United States where a landlord agrees to accept the voucher. Landlords do not have to accept Section 8 tenants, but neither can local governments prevent recipients from using the vouchers in their communities.

The location and number of Housing Choice vouchers in the Village of Skokie has often been brought up as an issue of concern by residents. Apartment units being inhabited by such voucher recipients are primarily located in the multiple family zoning districts, although a voucher could be used to rent a single family home.

The number of vouchers used in the Village has actually declined annually for the past few years from a high of 457 units in 2006 to 414 units in 2011. The Housing Choice vouchers assist many people with lower paying jobs to afford safe and clean housing in the Village. Although there is a perception that Housing Choice voucher users may contribute to crime in the community, there is no evidence that there is a correlation between crime and voucher holders.

If Skokie has had a property tax freeze since 1990, why are my property taxes always going up?

Skokie is only one taxing jurisdiction out of the more than a dozen different taxing bodies represented on property tax bills. Schools comprise approximately 68% of an average property tax bill and increase each year as permitted by tax caps and/or approved referendum.

What is the status of the Village's Finances?

The Village's award-winning budget continues a tradition of careful financial management while maintaining Village services. During the recession the Village was able to achieve a AAA bond rating from two rating agencies, a significant accomplishment (Moody's and Fitch). The Village's property tax levy of \$15.4 million is the same as it was in 1990 due to the self-imposed property tax freeze. Over the years of the self-imposed property tax freeze, **Skokie's percent of an average taxpayer's property tax bill has decreased from 15.2% to 7.3%.** ∞

Skokie Boulevard and Oakton Street Improvements

There are numerous construction and improvement projects that are underway, upcoming or just completed in the eastern section of Downtown Skokie at Skokie Boulevard from Main to Oakton Streets and on Oakton Street east of Skokie Boulevard. A summary of the project includes:

CTA Yellow Line Oakton Station in Downtown Skokie

Also known as the Oakton-Skokie Station, the construction project remains on schedule and on budget. The “Kiss & Ride” station will provide service to both the Dempster-Skokie and Howard Street stations, and is expected to become operational in 2012.

Traffic Signal at Searle Parkway and Skokie Boulevard

The Illinois Department of Transportation recently issued a permit for installation of a traffic signal at the intersection at Skokie Boulevard and Searle Parkway adjacent to the new Oakton-Skokie Station. Installation takes place in fall 2011, with the signal operational in early 2012.

Skokie Boulevard Streetscape

The Village recently completed a streetscape project on Skokie Boulevard from Main Street south to Oakton Street being paid for largely with federal funds. The project included installation of new sidewalks, light poles, trees, decorative

brick pavers in select areas and other amenities to improve the area’s appearance in advance of the Oakton-Skokie station opening early next year.

Oakton Street Streetscape

The Village recently received another federal grant to install streetscape amenities on Oakton Street from Skokie Boulevard to approximately Lowell Avenue. In commercially zoned areas, project amenities will be similar to those described in the Skokie Boulevard streetscape section. Plans will be completed in coming months with construction in 2012.

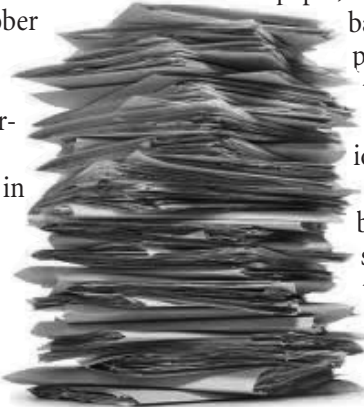
Skokie Valley Trail

The 10-foot-wide multi-use path will run along the west side of the CTA tracks from Oakton Street north to Dempster Street. The path will meet industry design standards for bicycle and multi-use paths and will include two-foot aggregate shoulders on both sides. Installation of the asphalt path and aggregate shoulders will take place in fall 2011, with landscaping installation set for spring 2012.

The project is being funded by one of the Village of Skokie’s Tax Increment Financing Districts and from a federal grant. Plans are being developed to extend the Skokie Valley Trail south of Oakton Street to the southern Village limit. ∞

Skokie Document Destruction Event

The Consumer Affairs Commission will host a document destruction event on Sunday, October 23, 2011 at the Skokie Farmers' Market. The event is held in cooperation with the Skokie Chamber of Commerce. Proper de-



struction of documents such as residentially generated paper, medical forms, bank statements, personal files, retired tax forms, etc. prevents identity theft. No materials from businesses, schools or institutions will be accepted. The event will

be held from 9 a.m. to noon in the Village parking lot just east of the Farmers' Market.

Halloween 2011



It's time for kids and their parents to don costumes in Skokie for trick-or-treating. Halloween is Monday, October 31 and trick-or-treating hours are from 3 to 8 p.m. Please respect the privacy of other residents and do not ring doorbells before or after this period. If the outside house light is off, do not disturb the homeowner by ringing the doorbell. Remember these tips to have a SAFE HALLOWEEN:

- S** words, knives and similar costume accessories should be short, soft and flexible.
- A** void trick-or-treating alone. Walk in groups or with a trusted adult.
- F** asten reflective tape to costumes and bags to help drivers see you.
- E** xamine all treats before eating them for choking hazards and tampering. Limit the amount of treats you eat.
- H** old a flashlight while trick-or-treating to help you see and to help others see you.
- A** lways test make-up in a small area first and remove it before bedtime to prevent skin and eye irritation.
- L** ook both ways before crossing the street and use established crosswalks.
- L** ower your risk for serious eye injury by not wearing decorative contact lenses.
- O** nly walk on sidewalks or on the far edge of the road facing traffic to stay safe.
- W** ear well-fitting masks, costumes and shoes to avoid blocked vision, trips and falls.
- E** at only commercially-wrapped treats. Avoid eating homemade treats unless you know the chef well.
- E** ntering homes for treats should be avoided unless accompanied by a trusted adult.
- N** ever walk near lit candles or luminaries. Be sure to wear flame-resistant costumes.

Flu Shot Clinics Continue By Appointment Only

The Skokie Health Department will offer influenza ("flu") shots, **by appointment only**, to Skokie residents this fall. **Proof of Skokie residency will be required** for all participants, and appointments will be given on a first-come, first-served basis. You can make your own appointment online at www.skokie.org or by calling the Health Department at 847/933-8252.

The clinics will be held on Monday, October 3 from 3 until 7 p.m. and on Tuesday, October

11 from 10 a.m. to 2 p.m. **These are appointment only clinics. No walk-ins will be taken.** Participants covered by Medicare Part B are asked to bring their card with them to the clinic. This is necessary for the Health Department to receive reimbursement from Medicare.

The clinics will be held at the Oakton Park Community Center, 4701 Oakton Street. This site is accessible to people with disabilities and is also accessible via the #97 and #54A buses. ↻

When Your Carbon Monoxide Alarm Goes Off

When your carbon monoxide detector or smoke alarm activates in your home do not take it lightly. Carbon monoxide poisoning can have deadly results and a fire can consume a home very quickly.

If either of these detectors sounds an alarm please call 9-1-1 immediately. There is no charge or cost associated with this service. Also, remember to have a qualified technician inspect your fuel-burning appliances and chimneys each year before the heating season starts to make sure they are operating correctly and that there is nothing blocking the fumes from being vented out of the house.

The Skokie Health Department's Environmental Health Division also offers free carbon monoxide screening for Skokie residents. Call the Health Department at 847/933-8484 to make an appointment. ↻
