Sealed Bids will be received by the City of Sturgis in the City offices located 130 N. Nottawa, Sturgis, Michigan 49091 until 4:00 p.m. local time, **Monday, March 12, 2018**, at which time they will be publicly opened and read aloud.

Items of work include approximately 1,500 square yards of pavement removal and resurfacing; 300 tons of HMA, 318 feet of sanitary sewer replacement on S Clay Street; 315 feet of sanitary sewer extension on McKee Street; various rehabilitations of sanitary sewer and sanitary manholes throughout the project and all related work.
