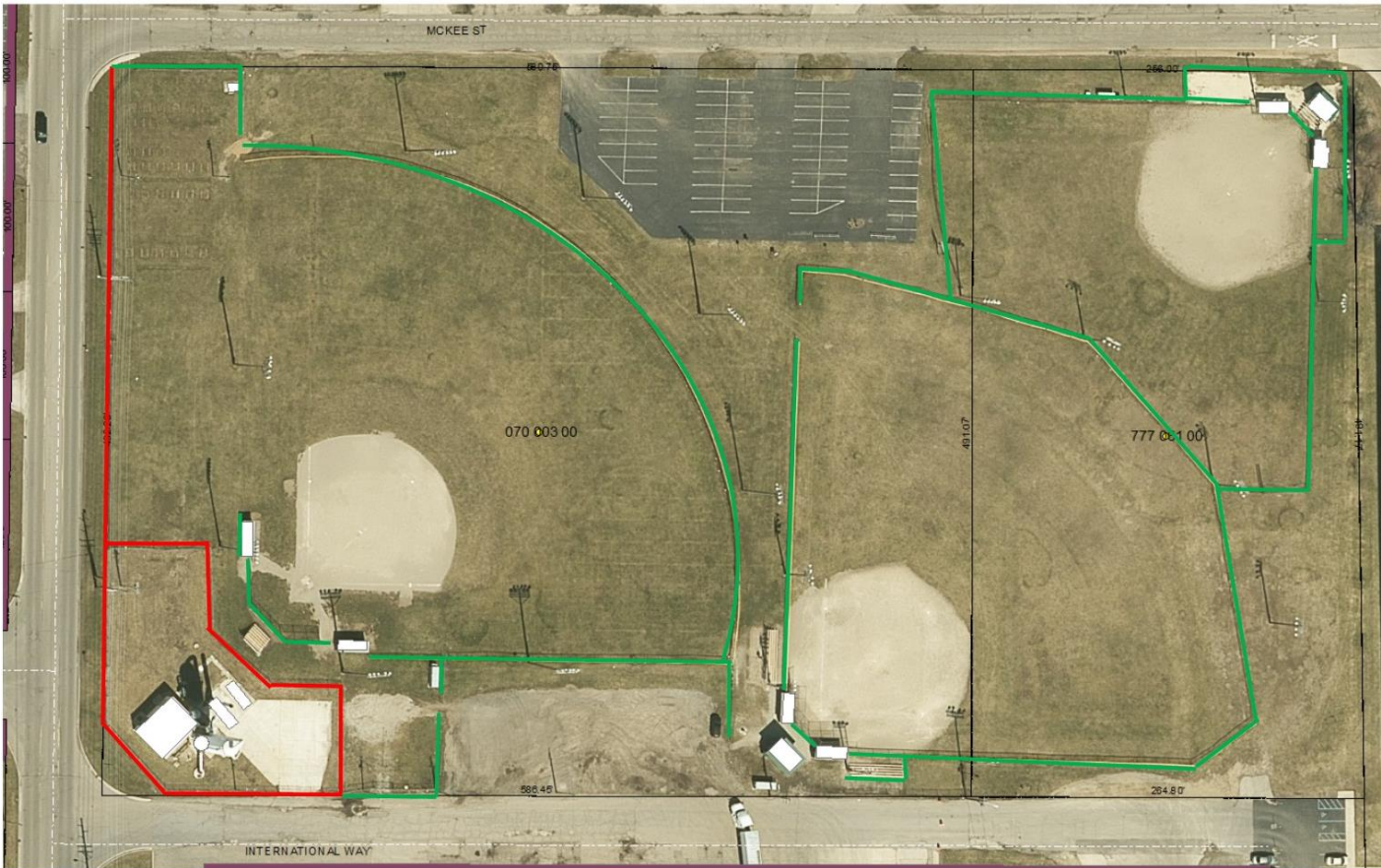

1. City will receive sealed Bids for removal of all or some of the fencing from the old Spence Field at the City of Sturgis, City Manager’s Office, 130 N. Nottawa Street, Sturgis, Michigan 49091 until February 12, 2018, 4:00 p.m., local time. No Bids will be received after this date and time. Bids must be submitted on this form and shall be enclosed in an opaque, sealed envelope, marked with “Old Spence Field Fence Bid Enclosed” and the name and address of the Bidder. Do not submit an envelope so marked unless a valid Bid is enclosed.
2. The City reserves the right to waive any irregularities and to reject any and all Bids.
3. The undersigned Bidder proposes and agrees, if this Bid is accepted, to remove the section(s) of fencing and posts from the old Spence Field within two (2) weeks upon bid acceptance. The area where fencing and posts are removed shall be left clean from debris and waste. If the fence is not removed within two (2) weeks upon acceptance, the bid will be null and void unless approved by the City.
4. This Bid is genuine and not made in the interest of or on behalf of any undisclosed person, firm or corporation and is not submitted in conformity with any agreement or rules of any group, association, organization or corporation; Bidder has not directly or indirectly induced or solicited any other Bidder to submit a false or sham Bid; Bidder has not solicited or induced any person, firm or corporation to refrain from bidding; and Bidder has not sought by collusion to obtain for itself any advantage over any other Bidder or over City.
