ISSUE

Shall the Village Board approve an amendment of the Village Code increasing the number of residential chicken permits from eight (8) to sixteen (16).

DISCUSSION

The Village Board discussed the residential chicken permit program at its January 4, 2022 meeting. The consensus among the Board was to increase the authorized number of permits from eight to sixteen. The attached Ordinance amends the maximum number of residential chicken permits (Section 5-4-14-F).

ORDINANCE NO. 2022-0118A

AN ORDINANCE AMENDING THE VILLAGE CODE TITLE 5, ANIMAL CONTROL (RESIDENTIAL CHICKEN PERMIT)

WHEREAS, the Village of Sugar Grove (the “Village”) is not a home rule municipality within Article VII, Section 6A of the Illinois Constitution and, pursuant to the powers granted to it under 65 ILCS 5/1-1 *et seq.*; and,

WHEREAS, from time to time, it is necessary and desirable to modify the regulations in the Village Code in response to changes in community attitudes, technology, development and the law; and,

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Sugar Grove, Kane County, Illinois, as follows:

SECTION ONE: VILLAGE CODE AMENDMENT

That Section 5-4-14-F-1 of Title 5 (Animal Control) of the Village Code of Ordinances be amended to be and to read as follows:

1. The Village shall issue a maximum of sixteen (16) permits authorizing the keeping of chickens.

SECTION TWO: GENERAL PROVISIONS

REPEALER: All ordinances or portions thereof in conflict with this ordinance are hereby repealed.

SEVERABILITY: Should any provision of this Ordinance be declared invalid by a court of competent jurisdiction, the remaining provisions will remain in full force and effect the same as if the invalid provision had not been a part of this Ordinance.

EFFECTIVE DATE: This Ordinance shall be in full force and effect on and after its approval, passage and publication in pamphlet form as provided by law.
