ISSUE

Should the Board adopt a resolution Amending Fees and the Number of Licenses per Liquor Class.

DISCUSSION

Per Title 3, Chapter 2 of the Village Code, from time to time the Village Board may set fees and the number of licenses for each liquor class. At the January 18, 2022 Village Board meeting, the Board discussed restoring liquor license fees for the 2022-2023 year to their pre-COVID level and to also establish a fee for the new Class R liquor license that allows video gaming at gas stations and convenience stores to \$3,750.00, which is \$2,500 in addition to the cost of a traditional Class P (Packaged Liquor) license.

The number of licenses has been reduced by one (Packaged Liquor) from the current year as the BP at Cross and IL 47 was sold and the new owners are currently not selling liquor. They have indicated they are waiting to apply for a liquor license until remodeling is completed. When any applications above the amount set in this resolution are received by the Village, the Board will approve a new resolution to increase the number of licenses per liquor class and assign that license to a specific establishment.

COST

The liquor license fees results in approximate revenue of \$18,000 for FY2022-2023 depending on when BP applies for a new license and for which license they apply.

RECOMMENDATION

That the President and the Board of Trustees adopt a resolution Amending Fees and the Number of Liquor Licenses Available per Class.

**Amending Fees and the Number of Licenses per Liquor Class
for the 2022-2023 Licensing Year**

BE IT RESOLVED, by the Board of Trustees of the Village of Sugar Grove, Kane County, Illinois as follows:

WHEREAS, Village Code Chapter 2, Section 3-2-7: Number of Licenses, provides that the cost and fees for obtaining and maintaining liquor licenses within the Village of Sugar Grove shall be set from time to time by the Board of Trustees of the Village of Sugar Grove by resolution of said Board of Trustees; and;

WHEREAS, Village Code Chapter 2, Section 3-2-7: Number of Licenses provides that maximum number of allowable per Class Licenses shall be determined by resolution by the Board of Trustees. In addition, the Board of Trustees may regulate the number of licenses by geographical area within the Village of Sugar Grove;

NOW THEREFORE BE IT RESOLVED, by the Board of Trustees of the Village of sugar Grove, Kane County, Illinois as follows:

That the annual fee for each class of liquor license and the number of licenses per Class within the Village of Sugar Grove shall be allocated as follows:
