ISSUE

Should the Village approve the purchase a replacement Utility Vehicle.

DISCUSSION

The FYE 23 Budget includes funds to purchase a replacement Utility Vehicle. The current John Deere Gator Utility Vehicle was purchased in 2010 and has reached its useful service life. Staff received a quote of \$24,528.64 from Polaris Government Purchasing Program for a Polaris Ranger Utility.

The existing John Deer Gator has been listed for surplus. Staff recommends selling via auction the existing John Deere Gator and Purchasing the Polaris Ranger Utility Vehicle thru the Polaris Government Purchasing Program as the replacement.

COST

The cost to purchase the Polaris Ranger Utility Vehicle is \$24,528.64. The Utilities Fund Budget Account number 50-59-6500: General Equipment has \$25,000.00 budgeted to purchase a replacement Polaris Ranger Utility Vehicle.

RECOMMENDATION

That the Village Board waives the bidding process and approve **Resolution # 20220419PW4** authorizing the purchase of a Polaris Ranger Utility Vehicle in the not to exceed amount of \$24,528.64 from Polaris Government Purchasing.
