ISSUE

Should the Village Board approve a resolution to purchase LED Street Light Retrofit Kits.

DISCUSSION

Staff applied for the ComEd Energy Efficiency Program Incentive to convert all the Street lights to LED within the Windstone and the Black Walnut Trails Subdivision for a total of 113 street lights. The grant covers replacing the existing 113 cobra style street light fixtures with LED light fixtures. The cost for the LED Retrofit Kits is \$286.55 each for a total of \$33,239.80. With the COMED Incentive of \$10,393.60 the cost is reduced to \$22,846.20. In addition to the decrease in energy consumption of 65% and lighting maintenance costs, the village will see savings in longer light lifespan. The new LED lighting fixtures are estimated to last approximately 20 years versus the current village lighting fixtures, which require replacement approximately every five years. Staff received 2 proposals for 113 LED Street Light Retrofit Kits from local suppliers that conform to the COMED Program.

The LED Street Light Retrofit Kits would be installed in house by Public Works staff.

COST

The cost to purchase the 113-replacement LED light fixtures is \$33,239.80. The ComEd Energy Efficiency Incentive would be \$10,393.60. The funds are in the Streets General

Fund Budget Account number 01-53-6610: Traffic Control Supplies. The account has \$35,071.00 budgeted to purchase replacement led light fixtures thru the Green Energy Civic Contribution that we are receiving through our choice with the Municipal Electrical Aggregation Program coordinated by the Finance Department.

RECOMMENDATION

The Village Board approve a resolution **#22020419PW1** to purchase LED Street Light Retrofit Kits in the amount of \$33,239.80. The final cost for the replacement LED Street Light Retrofit Kits with the ComEd Incentive of \$10,393.60 is \$22,846.20. The Streets General Fund Budget Account number 01-53-6610: Traffic Control Supplies has \$35,071.00 budgeted to purchase a replacement LED Street Light Retrofit Kits.
